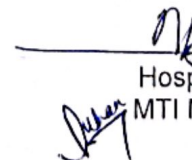

The bidders shall upload all the mandatory and relevant documents alongwith the bid security on the EPADS. Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.

General Terms & Conditions:

- i. The bidders should be registered with FBR and reflected on Active Tax Payer list (ATL)
- ii. All the bidders should also be registered with KP Revenue Authority (KPRA).
- iii. The biddin shall be carried out in light of KPPRA Notification No. SRO No (14)/Vol:1-24/2021-22 dated May 10th 2022.
- iv. In complete, conditional and Bids without bid security shall be considered as non-responsive.
- v. The bidders are required to submit only bid security @2% of the estimated cost (in original) in physical form in shape of Call Deposit Receipt (CDR)/ Demand Draft (DD)/ Pay Order or Banker's Cheque in the name of "Hospital Director MTI-Mardan".
