1. KPEZDMC invites bids under a single-stage one-envelope procedure through the E-Pak Acquisition and Disposal System (EPADS) from eligible and registered bidders with FBR & KPRA (Income Tax and Sales Tax) for the following procurement.

2. The event management firm will be hired through framework agreement for the period of one year, therefore the rate will be locked for items as mentioned in Annexure-A. The events location shall include but not limited to areas of KPK i.e. Peshawar Economic Zone, Jalozei Economic Zone, Mohmand Economic Zone, Rashakai Special Economic Zone, Nowshera Economic Zone, Export Processing Zone Risalpur, Gadoon Economic Zone, Ghazi Economic Zone, Hattar Economic Zone. Hattar Special Economic Zone (Phase 7), Bannu Economic Zone, Dera Ismail Khan Economic Zone, Buner Economic Zone, Mansehra Economic Zone, Katlang Economic Zone, Salt and Gypsum City Karak, Chitral Economic Zone.
3. All bids must be submitted electronically via EPADS (kp.eprocure.gov.pk) on or before 02:30 PM, October 05, 2026. Manual submissions of the bids will not be accepted under any circumstances.
4. The bids will be opened electronically on the same day at 03:00 PM, in the presence of bidders or their authorized representatives who wish to attend the bid opening meeting at the address below.
5. A bid security of PKR 50,000/- must be required in the form of a Call Deposit Receipt (CDR) issued by a scheduled bank in favor of KPEZDMC.
6. The original Bid Security shall be scanned and uploaded along with the bid on EPADS (kp.eprocure.gov.pk). The original bid security must be submitted in a sealed envelope to the KPEZDMC Head office: Plot No. 23, Street No. 13, Sector E-8, Phase 7, Hayatabad, Peshawar, before the bid submission time, mentioning the tender title and the bidder's details.
7. Failure to submit the original Bid Security within the deadline will result in rejection of the bid under KPPRA Rules.
8. KPEZDMC reserves the right to reject any or all bids at any stage of the bidding process as per prevailing KPPRA rules.
