2. The interested and eligible firms/contractors shall deposit a non-refundable fee of PKR 2,000/- into WSSC Swat Account No. 0012-0020-0649-6221, Bank of Khyber, Saidu Road, Makanbagh, Mingora, Swat. The original deposit slip for the fee of Rs. 2,000/- along with the original bid security shall be submitted before the closing date and time of bid submission.
3. The Firms / Bidders/contractors quoting their bid up to a limit of 10% below the Engineer's Estimate shall submit a bid security @2% only of the Engineer's Estimate, in favor of the **Chief Executive Officer-WSSC Mingora Swat**, and must be uploaded on **EPADS** along with the bid, and the original will be delivered before the closing time through a sealed envelope to the WSSC Swat office at the address mentioned below. The Bid Security envelope must be clearly and boldly marked as **"Bid Security for the [Name of Work]**.
4. The contractors quoting their bids more than 10% below up to 20% below the Engineer's Estimate shall submit along with their bids 8% Additional Security of the Engineer's Estimated cost in addition to 2% bid security.
5. The bid Security and additional Security shall be submitted as per KP-PPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10-05-2022 and No. S.R.O. (29)/Vol:1-40/2025 dated 29-10-2025.
6. The last date and time for online clarification is **28th September 2026** up to **5:00 PM**.
7. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA).
8. All Federal and Provincial duties, stamp duty, taxes, including sales tax, and other applicable charges shall be recoverable/deducted as per the prevailing Government rules and directives issued from time to time.
