Terms and Conditions:

1. Bid Solicitation Documents can be downloaded from the E-PADS i.e. (www.kp.eprocure.gov.pk) and KPPRA websites after publishing of NIT.
2. The eligible contractors/fabricators/manufacturers are required to submit their technical and financial Bids through E-PADS, also send their bids in sealed envelopes and sent to the **Office of TMO, Tehsil Municipal Administration, Eagle Fort Complex, Dara Adam Khel**, through registered courier service before bid submission due time.
3. The securities shall be in shape of call deposit in favor of the **TMO, Tehsil Municipal Administration, Dara Adam Khel**. Clear scan copies shall be uploaded on EPAD system and the same instruments shall be sent through registered courier up to the closing time of bids.
4. The last date and time of submission of electronic tender form is **12th October, 2026 at 12:30 PM**. Technical bid will open on the same date at **1:30 PM**. The date and time of Opening of Financial Bid shall be announced/communicated after evaluation of technical bids through provided email.
5. Original TWO (02%) Bid Security of the total bid price in the shape of CDR in the name of TMO TMA Dara Adam Khel, shall be sealed in envelope and marked as such and shall reach this office before the closing date and time.

6. All applicable taxes including sales tax, Income tax, KPRA taxes, stamp duties etc as per Govt. rules enforced shall be applied, the manufacture/Supplier should provide FBR registration. Tax payer certification, may which the bid well also be considered non-responsive.
7. Technical proposals must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
8. Any disfiguring / overwriting, manipulation in the tenders shall be liable to rejection.
9. The "Technical Proposals / Bids" of the contractors/fabricators/manufacturers will be evaluated based on criteria mention in the bidding Documents.
10. The scope of the work can be increase or decrease as per requirements, non-BOQ Items if any, will be paid as per MRS 2025 (1st BI Annual) / MRS based analysis if non – scheduled.
11. The "Financial Bids / Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders/ their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors/fabricators/manufacturers.
12. Matters related to the retaining of Bid Securities and failure to submit Bid Security & Additional Security shall be dealt with in accordance with KPPRA Notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022.
13. Bidder who does not comply the mandatory requirements will not be considered for technical evaluation and will be declared as non-responsive.
14. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss.
15. The successful bidder shall furnish Performance Security @ 10% of the Contract Price in accordance with KPPRA Rules and contract conditions.
16. The Procuring Entity reserves the right to reject any or all bids or cancel the bidding process at any stage prior to acceptance of a bid as per KPPRA Act, 2012 and KPPRA Rules, 2014.
17. The chassis shall be provided by the Procuring Entity. The contractor shall be responsible for complete fabrication, installation, testing, commissioning, painting, and delivery of the hydraulic dumper bodies in fully operational condition, including a minimum one-year defect liability/warranty period from the date of successful commissioning.
18. Successful bidder shall provide complete operational training to the staff of procuring entity.
19. Work order will be issued subject to fund availability.
20. Bids will remain valid for 90 days from the closing date of bids.
21. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the Bidder/Contractor signing the bid.
22. The Bidder/Firm must have PEC Specialization Codes ME05 Lifting, Handling and Material Processing Plants and ME06(i) – Specialized Fabrication and Treatment, as per PEC guidelines.
23. All applicable taxes shall be recovered in accordance with the directives of the government.
24. The Procuring Entity has allocated a fixed budget for this procurement. Only those bids whose evaluated bid price is within the approved allocated budget/funds provision for the subject work shall be considered for further evaluation and award. Bids exceeding the approved allocated amount may be rejected in accordance with the applicable provisions of KPPRA Rules and the approved procurement plan.
25. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
