(Single Stage–Single Envelope Procedure through EPADS)

Tehsil Municipal Administration BARA, Government of Khyber Pakhtunkhwa, based on MRS-2025 (1st Bi-Annual), hereby invites bids electronically through EPADS (E-Pak Acquisition and Disposal System) under the Single Stage–Single Envelope procedure in accordance with KP-PPRA Rules, 2014 from eligible firms / contractors registered with the Pakistan Engineering Council (PEC) in relevant category and enlisted with Local Council Board, Khyber Pakhtunkhwa, for the financial year 2026-27 having the required field of specialization for the following works:

TERMS & CONDITIONS

1. A complete set of Bid Solicitation Documents (BSD), (i/e including bidding documents, Bill Of Quantity, Criteria for i,Basic Eligibility/Mandatory, ii, Financial Bid Evaluation etc) shall be download from the official websites of E-PAK Acquisition & Disposal system (EPADS of PPRA/KP-PPRA) at (<https://kp.eprocure.gov.pk>) and bidders are required to provide in original Pay Order/Demand Draft/Bank Slip in favour of the TMO, TMA Bara amounting to **Rs(0.03%)** is documentation non-refundable fee against each work.
2. Interested bidders can obtain any further information / clarification from TMA BARA District Khyber.
3. Only eligible registered contractor can obtain tenders form/BSDs.
4. The bid must be submitted electronically through EPADS via <https://kp.eprocure.gov.pk> (scanned copy) on or before the date and time specified in the above-mentioned schedule against each work/contract. The original bid documents shall also be submitted in a sealed envelope to the office of the Tehsil Municipal Officer, TMA Bara, District Khyber.
5. The received bids shall be opened (downloaded from EPADS) on the date and time specified for opening of bids in the presence of the bidders or their authorized representatives who may choose to attend
6. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
7. The content of bids ,uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive
8. The following documents must be attached with the bid such as (i) 2% earnest money in shape of original call deposit in the name of **TMO, TMA BARA District Khyber** from scheduled banks (ii). Enlistment copy of Local Council Board for the year 2026-27 (iii). Registration copy of Pakistan Engineering Council for 2026-27 and (iv). Copy of CNIC & (v). Copy of KPRA Registration for 2026-27 for each scheme in a separate envelope highlighting name of work (written over the envelope).
9. Sealed bids must be sent through registered courier service on or before dated fixed for opening and bid will be opened on the same date at **02.00 PM** in the presence of bidders by the tender committee. By hand submission of tender documents will not be accepted and such tender will not be entertained.
10. Bidder who submitted their bids without a valid call deposit will be barred from participating in bidding process for one year.
11. Submission of the bid by the contractor/firm implies that they are fully conversant with the site, scope of the work and terms and condition laid down in the tender/bid document.
12. The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals the procuring entity shall upon request communicate to any contractor who submitted a bid or proposal the grounds for rejection or proposals as per KPPRA Rule 47.
13. The tender shall be processed according to “above / below system” based on market rate system.
14. The engineer estimate is framed on the current MRS 2025 (1st Bi-annual),If any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025/ prevailing market rates for NSI with the approval of the competent authority.
15. Tender forms and BOQs must be signed by the original contractor.
16. Bid security of some or all the bidders will be retained by the procuring entity till approval of tender / bid validity period.
17. The Department will not be bound to provide any machinery / testing laboratory and the total cost on it will be borne by the contractors themselves.
18. The bidders should be enlisted with the Khyber Pakhtunkhwa Revenue authority, as per KP-PPRA rules.
19. The bidders shall also submit their Bids (Hard Copy) with requisite documents i-e: - E-Tender Form, Signed BOQ, Active NTN Income Tax Certificate, PEC, LCB & KPRA Registration (Active), 2% earnest money, additional security if any (original in shape of CDR) & a certificate to the effect that there is no dispute of the Firm with any department involved litigation/arbitration on the left over incomplete projects and blacklisting on Stamp paper to the office of the undersigned through Registered Courier Service before the closing time. The Bids received by hand, not through Registered Courier Service and late shall not be entertained.
20. Tender documents of bidder if found with bogus/false documents will be rejected and their registration shall stands cancelled/blacklisted in addition of forfeiture of earnest money.
21. All Pages of the tender/bid documents shall be initiated and official seal be affixed by the person of persons signing the bid.

22. Cutting/Over writing/manipulation in Bid Solicitation Documents will not be acceptable. Any mismatching in scanned copies uploaded on EPADS and that submitted in hard will lead to disqualification and the same will be treated as non-responsive.
23. In case of tie between bidders, successful bidder will be decided through Draw/toss.
24. Only up to Two Decimal Digits (0.00) will be considered for evaluation of the quoted Bid. If any document submitted along with bid documents found false bogus, the registration of the Contractor /Firm shall stands cancelled blacklisted.
25. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security to the extent of 2% of Engineer Estimate only. The contractor quoting their bids more than 10% below up to 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of the TMO, TMA Bara District Khyber and the second lowest bidder and so on will be considered accordingly. It is to clarify that additional security will be provided in shape of call deposit in name of TMO TMA BARA District Khyber.
26. Any matter not specifically covered in these Terms & Conditions shall be dealt with in accordance with the KP-PPRA Act, 2012, KP-PPRA Rules, 2014, and amendments thereto, and the notifications/circulars issued by KP-PPRA from time to time, including Notification No. S.R.O.(14)/Vol:1-24/2021-22/6058-71 dated 10-05-2022 and Notification No. S.R.O.(29)/Vol:1-40/2025-26/699-711 dated 29-10-2025, as applicable.
27. Payment to the contractor shall be made against satisfactorily executed, measured and verified work, subject to the availability/release of funds, completion of all codal formalities and approval of the competent authority. In case of delay/non-release of funds by the competent authority, the Procuring Entity shall not be liable for any claim of interest, compensation or damages on account of such delay.
28. The Successful bidder shall furnish the prescribed Bank Guarantee / Performance Security within 28 days of issuance of LOA. In case of failure, the award shall be annulled and the next lowest evaluated bidder shall be considered as per KPPRA Rules.
