The procurement will be governed under Rule 6(2)(b) "Single Stage Two Envelope" procedure of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules, 2014. Participating bidders—comprising Manufacturers, Importers, and Authorized Distributors for Importers—must be registered for Income Tax and Sales Tax, actively listed on the Active Taxpayer List (ATL) of the Federal Board of Revenue (FBR).
