Terms & Conditions.

1. Bidding Solicitation Documents along-with Bidding Criteria, and instruction to bidders can be downloaded from the official EPADS website and C&W website (www.cwd.gkp.pk) as well as KPPRA website (www.kppra.gov.pk) before the submission time. Bids submitted without requisite documents or incomplete will not be processed further for Technical Evaluation.
2. Bidders shall be required to submit an affidavit on stamp paper and place the same affidavit in the Technical Proposal, affirming that the CDR enclosed in the sealed financial bid is authentic and original. In case of non-availability of the Affidavit, the firm/bidder shall be considered as non-responsive.
3. Original Copies of Call Deposit Receipts (CDRs) for Bid security (from Scheduled Banks), Stamp Duty is mandatory as well as Bid Entry Fee (Non-Refundable) for each bid @0.03% of the Estimated Cost without fail; to be enclosed along-with the Technical Proposal and shall reach to the office before closing date / time.

4. A copy of the Technical Proposal as well as Financial Securities in the required format is mandatory and to be uploaded on EPADS System.
5. Electronic bidding will be done on "Above/Below" system on BOQ/Engineer's Estimate, based on MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
6. Electronic Bids will be displayed by online E-Bidding through EPADS system after 30-Minutes of closing time in presence of bidders/their representative.
7. Bid Security of 1st, 2nd & 3rd lowest bidder will be retained by the Procuring Entity till approval of the bid.
8. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
9. The Competent Authority reserves the right to reject any or all the tenders by assigning the cogent reason(s).
10. Bid will be valid for (90) days.
11. All other terms & conditions in-clouding KPPRA amended Rules can be seen on official website of the C&W Department or from the office of the undersigned on any working day during duty hours.
12. All Federal /Provincial duties/ Stamp duties/ Taxes will be recovered as per directions of the Government issued from time to time.
13. Joint Venture (JV) is allowed, as per C&W Rules and Regulations / KPPRA Rules.
14. Separate Brochure / Technical Proposals for each work along-with required documents shall be submitted clearly mentioning the Scheme Name and No.
15. The participating contractor(s) must submit their updated FBR (Active Status), KPRA (Active Status), PEC License and C&W Enlistment copies for the current financial year, for each work, on the day of opening of tender(s).
16. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under Finance Act, 2013 Act No. XXI of 2013.
17. The Financial Bid will be opened after the approval of Technical Bids from the Competent Authority.
18. Period of Completion will be based on Work Order(s).
19. Any condition/Instructions, if missing, will be dealt in light of the KPPRA rules.
20. Contractors whose past performance is not satisfactory with this Division shall be considered as non-responsive.
21. Pre-Bid meeting will be held on 07/10/2026 (Wednesday) in the office of C&W Highway Division Khyber at 11:00 AM.
22. Venue of bids opening is office of the Executive Engineer Highway Division District Khyber at Jamrud.
