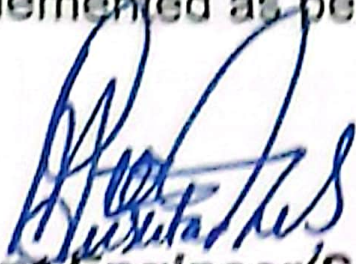

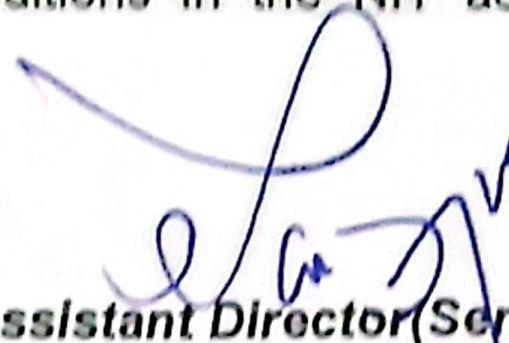
Terms and Conditions:

1. The bidding Documents can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and KP-PPRA website (kppra.gov.pk). Cutting/overwriting/manipulation in the bidding documents will not be acceptable, in the scanned copies submitted through EPADS.
2. The bid security and (additional security if applicable) must be prepared in favor of Assistant Director LG&RDD, Tehsil Headquarter Babuzai Swat in light of KPPRA Notification No.S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022 and must be delivered to the Office of Assistant Director Senior LG&RDD Tehsil Head Quarter Babuzai, District Swat before closing time of bids.
3. The bidder must upload original Bid securities, CNIC, KPRA enlistment/Registration, C&W enlistment, PEC registration, FBR active taxpayer status, Non Blacklisting & No litigation affidavit & detail rate analysis (if applicable), complete in all respect through EPADS.
4. The original CDR/Bid securities must be submitted to the office of the **Assistant Director Senior, Local Government and Rural Development Department Tehsil Headquarter Babuzai** before closing time of the bids.
5. The rates may be offered as % above/below or at-par on engineer estimate.
6. The eligible contractors/firms must have relevant codes of Pakistan Engineering Council (PEC).
7. Any electronic bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in original will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
8. Bids will remain valid for 90 days from the closing date of bids.
