The Directorate General of Sports, Government of Khyber Pakhtunkhwa invites Technical and Financial Proposals through the E-Pak Acquisition and Disposal System (EPADS) under National Competitive Bidding from qualified local and national Service Providers having a minimum of five (05) years of relevant experience in the execution of similar services, for Three (03) service packages under Framework Contract, in accordance with the applicable provisions of the KPPRA Rules, 2014.

TERMS & CONDITIONS: -

1. Bidders must be registered with KPRA; hold valid NTN and GST certificates, and appear on the Active Taxpayer List (ATL). A valid registration certificate from the Registrar of Firms (Form-H) / SECP registration must be provided where applicable.
2. Procurement will be conducted through the Single Stage–Two Envelope procedure under Rule 14(2) (b) of the KPPRA Rules; 2014. The bidder must clearly mention their postal address, valid email address, and active contact numbers.

Late submissions will not be entertained.
5. Bidders must submit separate bids for each package and quote package-wise rates.
6. Bidders must submit a Bid Security of Rs. 1,000,000/- (Rupees one Million only) in the form of a Call Deposit Receipt (CDR), separately for each package, drawn in favor of the Director General of Sports, Government of Khyber Pakhtunkhwa.
7. A pre-bid meeting will be held on 6th October 2026 at 12:00 Noon in the Committee room, Directorate General of Sports, Peshawar.
