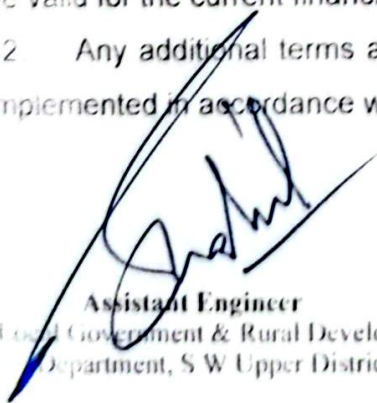

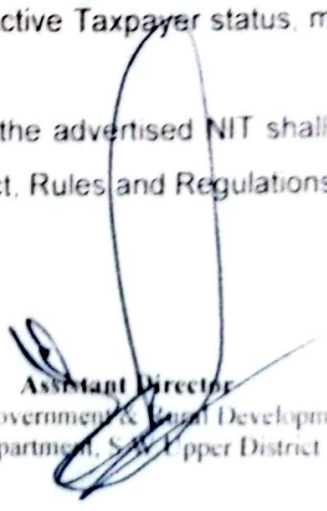

Terms and Conditions:

1. The Bidding Documents uploaded by the Office may be downloaded from the official EPADS website (www.eprocure.gov.pk) and the KP-PPRA website (www.kppra.gov.pk) after publication of the NIT. The bidder shall complete the Bidding Documents neatly and upload a clear scanned copy through EPADS at the time of bid submission. Cutting, overwriting in the Bidding Documents shall not be acceptable. The Bid Security in the form of a CDR shall be prepared in favor of the Office of Assistant Director (Sr) LG & RDD District South Waziristan Upper. The Bid Security shall be prepared after publication of the NIT and before the closing time of the electronic bid. The original Bid Security shall be delivered through courier to the Office of Assistant Director (Sr) LG & RDD District South Waziristan Upper.
2. Rates may be quoted as a percentage above, below, or at par with the Engineer's Estimate.
3. The Bidder must possess the relevant PEC codes applicable to the above-mentioned schemes.
4. The last date and time of submission of electronic tender form is 15th October 2026 at 12:30 PM.
5. Matters relating to Bid Security and applicable additional security failure to submit Bid Security shall be governed by KP-PPRA Notification No. S.R.O. (29)/Vol: 1-40/2025-26/699-711 dated 29th October 2025. The requirements relating to Additional Security shall comply with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May 2022.
6. In case the quoted rates are more than 20% below the Engineer's Estimate, the bidder shall upload a detailed rate analysis along with valid and justifiable supporting documentation.
7. The Contractor or his authorized representative may be present at the time of opening of the electronic bids.
8. In case of a tie/draw among responsive bidders, the successful bidder may be determined through a draw/toss, and the outcome shall be considered final.
9. Bids shall remain valid for 180 days from the closing date of submission of bids.
10. All applicable taxes shall be deducted/recovered in accordance with the prevailing Government rules, notifications, and directives.
11. The bidder's PEC and KPRA registration, including Active Taxpayer status, must be valid for the current financial year.
12. Any additional terms and conditions incorporated in the advertised NIT shall be implemented in accordance with the applicable KP-PPRA Act, Rules and Regulations.
