PURPOSE OF TENDER

Pakistan Institute of Development Economics (PIDE) invites **SINGLE STAGE – ONE ENVELOPE PROCEDURE** under PPRA Rules from well reputed firms having minimum 3 years; experience in rendering similar services.

MODE OF ADVERTISEMENT(S):

Complete Tendering process shall be carried out through EPADS. Interested firms/bidders are requested to register themselves on the EPADS <https://eprocure.gov.pk/#/supplier/registration> and submit their tender documents. For registration and guidance/training on EPADS, you may contact EPADS UAN: 051-111-137-237.

As per Rule 12(1&2), this tender document is being placed online at PPRA's website, the website of procuring agency www.pide.org.pk as well as being advertised in print media.

TYPE OF OPEN COMPETITIVE BIDDING:

As per PPRA Rule, Single Stage One Envelope -Bidding Procedure shall be followed. The said Procedure is reproduced as follows:

36. Procedures of open competitive bidding.-

Save as otherwise provided in these rules the following procedures shall be permissible for open competitive bidding, namely:-

- i. Single stage – one envelope procedure.-
- ii. Each bid shall comprise one single envelope containing, financial and technical proposal (separately if any). All bids received shall be opened and evaluated in the manner prescribed in the bidding document.

TENDER PRICE & CURRENCY:

The quoted price shall be:

- Inclusive of all Government applicable taxes; and
- Denominated in Pak Rupees;

TENDER ITEM:

- Supply of Core Router with Installation & Commissioning (*Annex-A*)

BID SECURITY:

The Bidder shall furnish the Bid Security (Earnest Money) with the Tender Document and the same should be upload on EPADS, detail is as under:

- a) Bidders applying for “Supply of Core Router” to submit the Bank draft as earnest money of amount Rs. 50,000/- as a bid security in favor of “Pakistan Institute of Development Economics, Islamabad”.

OPENING OF THE TENDER:

PIDE shall open all bids through EPADS at the time, date, and place specified in tender notice, in presence of bidders’ representatives who wish to attend the meeting and shall sign an attendance sheet as evidence of their presence.

TERMS AND CONDITIONS:

The tenderers are required to fulfill the under mentioned conditions failing which the quotations will not be entertained:

- i. The proposal/bid in PDF file is required to be uploaded through EPADS.
- ii. The item will be delivered at the premises of the PIDE, Islamabad located at Quaid-i-Azam University Campus, Islamabad without any cost of transportation.
- iii. The tenderers shall have to deposit earnest money in the form of Pay Order/Demand Draft only (Cross cheques are not acceptable) in favor of Pakistan Institute of Development Economics, Islamabad along with proposal/bid for which applying;
- iv. The bid security will remain with the PIDE till the delivery of required item. It shall be forfeited, if the firm fails to supply the required item within stipulated period and as per specifications mentioned in the tender documents.
- v. Only registered suppliers, who are on Active Taxpayer List (ATL) of FBR, are eligible.
- vi. The firms must have established shop/office/workshop having sufficient stock in Islamabad / Rawalpindi, which can be inspected by the Institute’s Authorized Officer/Purchase Committee (if deem necessary).
- vii. Over writing and cutting of any nature in quotation(s) shall not be accepted and the quotation shall stand cancelled.
- viii. The participating firm (s) shall have to provide a copy of their G.S.T & NTN registration certificate.
- ix. The vendor shall give an undertaking on stamp paper that his firm has not been blacklisted by any of Provincial or Federal Government Departments, Agency, Organization or autonomous body etc. anywhere in Pakistan.

- x. In case, the supplier tries to supply sub-standard item, their contract shall be cancelled and earnest money shall be forfeited and the supplier shall not claim any relief in this situation.
- xi. The Institute reserves the right to accept or reject any or all the quotations under rule

TENDER ELIGIBILITY/QUALIFICATION CRITERIA:

Eligible Bidder/Tenderer is a Bidder/Tenderer who:

- a. Must be registered with Tax Authorities, and having valid registration of Sales Tax and NTN & also having sound financial strengths can participate (copy must be attached);
- b. Partnership with OEM and MAL; Authorized Gold Partner/ Reseller or Equivalent with MAL from OEM.
- c. OEM must be presence and support in Islamabad/Rawalpindi from the last five years.
- d. OEM Should be Gartner Leader in the Magic Quadrant for Enterprise Wired Infrastructure report/documents must be attached.
- e. Has submitted bid and relevant bid security. Non-compliance of the same shall cause rejection of the bid;
- f. Must be involved in relevant field for last five years (copy must be attached);
- g. At least 03 Previous reputation/work completion certificate and current working proof/reputation certificate. (Previous reputation shall be highly matter).
- h. Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous body or Private Sector Organization anywhere in Pakistan (submission of undertaking on legal stamp paper is mandatory), failing which will cause rejection of the bid;
