3. **Single Stage Two Envelop Bidding Procedure** of Principal Method of Procurement (i.e., Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS) Technique** for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time).

#### A. INTRODUCTION

<b>1. Scope of Bid</b>	<b>1.1</b>	The Procuring Agency (PA) as indicated in the <b>Bid Data Sheet (BDS)</b> invites Bids for the provision of Services as specified in the BDS and <b>Section V - Technical Specifications &amp; Schedule of Requirements</b> . Successful Bidders will be expected to deliver the services within the specified period and timeline(s) as stated in the <b>BDS</b> .
<b>2. Source of Funds</b>	<b>2.1</b>	Source of funds is referred to in Clause-1 of Invitation for Bids.
<b>3. Eligible Bidders</b>	<b>3.1</b>	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract. <i>(The limit on the number of members of JV or Consortium or Association may be prescribed in BDS, in accordance with the guidelines issued by the PPRA).</i>
	<b>3.2</b>	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency
	<b>3.3</b>	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
	<b>3.4</b>	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.
	<b>3.5</b>	The invitation for Bids is open to all prospective

		suppliers, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that trade or business.
	<b>3.6</b>	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process
	<b>3.7</b>	<p>A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:</p> <ol style="list-style-type: none"> <li>a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the services to be purchased under this Invitation for Bids.</li> <li>b. Have controlling shareholders in common; or</li> <li>c. Receive or have received any direct or indirect subsidy from any of them; or</li> <li>d. Have the same legal representative for purposes of this Bid; or</li> <li>e. Have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process;</li> <li>f. 	<b>3.11</b>	Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged
<b>4. Eligible Services and Related Services</b>	<b>4.1</b>	All services and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such services and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as "Eligible Countries".
	<b>4.2</b>	For purposes of this Clause, "origin" means the place where the items are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.

	<b>4.3</b>	The nationality of the supplier that supplies, assembles, distributes, or sells the services and services shall not determine the origin of the services.
	<b>4.4</b>	If To establish the eligibility of the items/Services, Bidders shall fill the country-of-origin declarations included in the Form of Bid.
	<b>4.5</b>	If so required in the <b>BDS</b> , the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the services to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the services indicated in its Bid..
<b>5. One Bid per Bidder</b>	<b>5.1</b>	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	<b>5.2</b>	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	<b>5.3</b>	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.

### Technical Specifications

#### Notes for Preparing the Technical Specifications

A set of precise and clear specifications is a prerequisite for bidders to respond realistically and competitively to the requirements of the Procuring agency without Qualifying their bids. The specifications must be drafted to permit the widest possible competition and, at the same time, present a clear statement of the required standards of workmanship, materials, and performance of the services and services to be procured. Only if this is done will the objectives of economy, efficiency, and fairness in procurement be realized, responsiveness of bids be ensured, and the subsequent task of bid evaluation facilitated. The specifications should require that all services and materials to be incorporated in the services be new, unused, and of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided for otherwise in the contract.

Samples of specifications from previous similar procurements in the same country are useful in this respect. The use of metric units is encouraged. Depending on the complexity of the services and the repetitiveness of the type

of procurement, it may be advantageous to standardize the General Technical Specifications and incorporate them in a separate subsection. The General Technical Specifications should cover all classes of workmanship, materials, and equipment commonly involved in manufacturing similar services, although not necessarily to be used in a particular procurement. Deletions or addenda should then adapt the General Technical Specifications to the particular procurement.

Care must be taken in drafting specifications to ensure that they are not restrictive. In the specification of standards for equipment, materials, and workmanship, recognized international standards should be used as much as possible. Where such standards and codes are national or relate to a particular country or region, other authoritative standards that ensure substantial equivalence to the standards and codes specified will be acceptable.

Reference to brand name and catalogue number should be avoided as far as possible; Where unavoidable (to complete an otherwise incomplete specification) they should always be followed by the words or equivalent.

Where appropriate, drawings, including site plans as required, may be furnished by the Procuring agency with the bidding documents. Similarly, the Supplier may be requested to provide drawings or samples either with its bid or for prior review by the Procuring agency during contract execution

At the event of failure of mediation to resolve the dispute relating to this contract such dispute shall finally be resolved through binding Arbitration by sole arbitrator in accordance with Arbitration Act 1940. The arbitrator shall be appointed by mutual consent of the both parties. The Arbitration shall take place in [Deputy Inspector General of Police, Motorway Central II, Multan.] and proceedings will be conducted in - [English] language.
4. The cost of the mediation and arbitration shall be shared by the parties in equal proportion however the both parties shall bear their own costs and lawyer's fees regarding their own participation in the mediation and arbitration. However, the Arbitrator may make an award of costs upon the conclusion of the arbitration making any party to the dispute liable to pay the costs of another party to the dispute.
5. Arbitration proceedings as mentioned in the above clause regarding resolution of disputes may be commenced prior to, during or after delivery of services.


