Original bid security must be submitted (hard format sealed envelop) before submission date & time at the address mentioned in bidding documents and the bid security scanned copy (pay order /bank guarantee) must be attached through EPADS online submission.

Bids must be submitted electronically before submission date & time. The electronics bids shall be opened on the same day at given time.

All bids will be opened through EPADS in the presence of procurement committee and bidders who opt to participate on date/time mentioned as per schedule.

Time period for performance of contract: Till the satisfactory completion of contract and warranty period.

PAA reserves all rights to accept and reject any or all the Tenders for sufficient and cogent reasons which will be communicated to the bidders on request. The decision shall be final / conclusive and shall not be challenged.
