REQUEST FOR PROPOSALS (RFP)

FOR HIRING OF A CONSULTANCY FIRM / INDEPENDENT EXPERT(S) FOR THIRD-PARTY VALUATION / VALIDATION OF THE 9TH PHASE PC-I (2007–2012) OF THE MANGLA WATERSHED MANAGEMENT PROJECT

1. The Employer, Pakistan Water and Power Development Authority (WAPDA), through the Project Director, Mangla Watershed Management Project (MWP), WAPDA, Islamabad, intends to engage a reputed consultancy firm / individual expert(s) for the provision of consultancy services for third-party valuation/validation of the 9th Phase PC-I (2007–2012) of the Mangla Watershed Management Project.
2. In this regard, the Request for Proposals (RFP) has been prepared in accordance with the PPRA Rules and WAPDA procurement procedures. The procurement shall be carried out under the Single Stage – Two Envelope procedure through the e-Pakistan Acquisition & Disposal System (e-PADS).
3. Proposals (Technical and Financial) are invited from eligible consultancy firms / individual expert(s). For consultancy firms, valid registration with the Pakistan Engineering Council (PEC), along with other prerequisites specified in the RFP and TORs, and an active National Tax Number (NTN) with FBR / FBR (GoAJK), are mandatory. Detailed eligibility criteria are provided in the RFP.
4. A pre-proposal meeting, if deemed necessary, may be held on or before 24.02.2026 during office hours at the office of the Project Director, Mangla Watershed Management Project, Office No. F-214, WAPDA Administrative Staff College Building, Sector H-8/1, Pitras Bukhari Road, Islamabad, to clarify queries, if any, of prospective consultants.
5. **Submission of Proposals:** Complete proposals must be submitted through e-PADS by 11:00 hours on 05.03.2026. Manual submissions shall not be accepted. The Technical Proposals shall be opened on the same day at 11:30 hours at Office of the General Manager (HRM), Room No. 227- WAPDA House, Lahore, whereas the Financial Proposals of technically qualified firms shall be opened subsequently, after completion of the technical evaluation.
6. **Taxes:** All applicable Federal, Provincial, and AJK taxes shall be borne by the consultancy firm / individual expert(s).
7. **Right to Accept / Reject:** The Employer reserves the right to accept or reject any or all proposals at any time prior to acceptance, in accordance with PPRA Rule 33(1).
