3. **Note:-** Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

4. Firms/contractors not borne on approved list of MES will furnish a certificate alongwith their applications statement of previous experience giving details of work executed during last two years and those in hand, on the proforma appended below:-
