Sealed Technical and Financial Proposals are invited from NTN and GST registered companies for, Provision & Installation of 11KVA dual feeder (IESCO) along with 630KW transformer and its allied equipment at Directorate General Immigration & Passports, HQ, Islamabad & installation/up-gradation of security equipment at regional passport office Quetta, in accordance with the "Bidding Documents which can be collected from Logistics Section of this office during office hours on payment of non-refundable Rs.2,000/- in the form of pay Order/ Demand Draft/ Banker Cheque in favor of Directorate General Immigration & Passports, by presenting request at company letter head.

4. **Terms & Conditions for Submission of Proposals:**

- National Tax Number (NTN) and Sales Tax Registration Certificate.
- The proposals must reach the undersigned on or before **25th March, 2026 at 11:30 AM**.
- The Tender shall be evaluated on the basis of both Technical & Financial Proposals, single stage two (2) envelope procedure will be adopted as per PPRA rule (Rule 36 (b) of PPRA Rules, 2004)
- Technical and Financial Proposals should be submitted in separate envelopes, the words 'Technical Proposal 'or' 'Financial Proposal' as the case may be, and **No.9/8/2025-26/ Security/Dual Feeder/Log** being clearly written on the top of the respective envelope, bidders are required to mention quoted lot also and both 'Technical and Financial Proposal' should be in one envelope.
- Initially Technical Proposal shall be opened by the Purchase committee on **25th March, 2026 at 12:00 PM** in the conference Room of this office. After technical evaluation, Financial Proposals of only technically qualified bidders shall be opened on a date/time to be announced subsequently.
- A fixed amount of bid security against each lot shall be provided with the tender in the form of a call deposit from any scheduled bank in favour of Directorate General Immigration & Passports the detail of bid security is as under:-
