**Other Terms and Conditions:**

- (a) The bidder interested to participate in the bidding process shall deposit a refundable bid security of Rs. 100,000/- (Rupees One hundred thousand only) in shape of demand draft / pay order in the favour of DDO MoDP before auction. Cheque or bank guarantee will not be accepted
- (b) All participants shall bring Original Computerized National Identity Card (CNIC) and also deposit attested photocopy of CNIC without which no body will be allowed to participate in the bidding process. The bidder shall also provide his complete address and telephone number.
- (c) The pay order of the unsuccessful bidder will be returned after completion of auction process and approval of competent authority.
- (d) Only those bidders who have deposited the required pay order shall be allowed to enter in the auction premises. Unauthorized people shall not be allowed to enter in the auction premises. The payment of outstanding token tax (if any) and cost of transfer of ownership documents will be the responsibility of successful bidder.
- (e) The successful bidder have to pay all Government Taxes as applicable in addition to bid amount.
- (f) The payment of outstanding token tax (if any) and cost of transfer of ownership documents will be the responsibility of successful bidder.
- (g) The Successful bidder deposit 10% of the bid amount at the spot in cash and the remaining amount of the bid including taxes within seven days after the approval of auction by the competent authority. In case of default by the successful bidder, the approval money shall be forfeited.

- (h) The documents of the vehicle will be handed over to the successful bidder after completion of procedural requirements and depositing of full amount of bid and taxes.
- (i) The successful bidder shall have to register the vehicle in his/her own name within fifteen days from the handing over documents at his/her own expense.
- (j) The vehicle will be handed over to successful bidder after transfer of ownership at his/her own name from the ETO concerned.
- (k) The Ministry reserves the right to accept or reject any bid without assigning reason.
- (l) Other details will be announced at the time of auction.
