NOTICE INVITING TENDER (E-PADS)

(E-Tender Notice No. 04/MWP/2025-26)

1. The Employer, Pakistan Water and Power Development Authority (WAPDA), through the Project Director, Mangla Watershed Management Project (MWMP), WAPDA, Islamabad, intends to invite E-PADS bids on percentage basis for from eligible firms/contractors for the following civil works.

2. Tendering Method:

The bidding shall be conducted through e-Pak Acquisition & Disposal System (EPADS) as per WAPDA/PPRA procurement procedures.

3. Eligibility Requirements:

The bidders must have:

- Valid PEC license for FY 2025-26 in Category C-6 or above with specialization codes CE-04.
- Registration with FBR/FBR (GoAJK) and inclusion in the Active Taxpayers List (ATL).
- Cashflow Statement/ Bank Statement.

4. Tender Documents:

E-Bidding documents, containing detailed terms and conditions, specifications, and requirements, are available for registered bidders on the E-PADS-WAPDA Websites and PPRA portal (www.eprocure.gov.pk).

5. Bid Submission & Opening

- Electronic bids must be submitted through E-PADS up to 12:00 hours on 08.04.2026. Manual bids shall not be accepted.
- Electronic bids will be opened on the same date at the time 12:30 hours in the Office of Project Office Mangla Watershed Management Project, WAPDA, Room No. F-214, WAPDA Administrative Staff College Building, Sector H-8/1, Pitras Bukhari Road Islamabad in the presence of bidders' authorized representatives who choose to attend.
- A Single Stage – Single Envelope Procedure shall be followed for this procurement.

6. Terms and Conditions

- a) Submission of false or misleading documents will result in forfeiture of bid security (CDR) and may lead to blacklisting of the firm as per WAPDA/PPRA rules.
- b) The bid security shall be submitted only in the form of a Call Deposit Receipt (CDR) in favor of Project Director, Mangla Watershed Management Project, WAPDA, Islamabad. (The firm's name must be clearly mentioned on the CDR). A scanned copy of the CDR shall be uploaded with the electronic bid, while the original CDR must be submitted to the undersigned on the date of bid opening but not later than 1100 hours, failing which the bid security shall not be accepted.
- c) The bidder must upload duly signed and stamped Forms of Bid, BOQ, and Contract Data; otherwise, the bid shall be rejected.
- d) The successful bidder shall submit a Performance Guarantee equal to 10% of the Contract Price, in the form of Pay Order/CDR as well as an Insurance Bond issued by an insurance company having at least 'AA' rating, before signing the Contract Agreement.
- e) All Federal, Provincial, and AJK taxes shall be borne by the Contractor/Bidder.
- f) The Employer reserves the right to accept or reject any or all bids/proposals at any time prior to acceptance, in accordance with PPRA Rule 33(1).
- g) The Tender Notice is also available on WAPDA and PPRA websites.
