Public Procurement is carried out in Pakistan in accordance with the provisions laid down in Public Procurement Regulatory Framework consisted of Public Procurement Ordinance-2002; Public Procurement Rules-2004 and allied Regulations, Regulatory Guides and Guidelines.

This document has been prepared in line with standard bidding documents for Hiring of Building for **Inland Revenue Service Academy, Lahore** (Single Stage One Envelope procedure) available at PPRA website. The clauses of this document may be applied where applicable/case to case basis for hiring of building for **Inland Revenue Service Academy, Lahore**.

National Standard Bidding/Procurement Documents are developed for standardizing the procurement procedures and practices in the procuring agencies of the Federation of Pakistan and has the status of the Regulations in terms of section 27 of the PPRA Ordinance read with Rule-23(4) of Public Procurement Rules.

The document consists of general as well as specific provisions to be applicable for the hiring. The specific provisions supplement to the general provisions and may be amended or opted by the procuring agencies in the manner and to the extent prescribed in the respective sections.

This document is a live document, and may be updated on quarterly basis considering the regulatory experience feedback based on monitoring the procurement practices and valuable suggestions of the stakeholders (i.e. procuring agencies, vendors and general public).

## SECTION I: INVITATION TO BIDS

### **FOR PROVISION OF ACCOMMODATION SERVICES FOR TRAINEE OFFICERS OF “INLAND REVENUE SERVICE ACADEMY, LAHORE”**

1. Inland Revenue Service Academy is a premier training institution under Federal Board of Revenue, Ministry of Finance, Government of Pakistan entrusted to train officers and staff of Inland Revenue Wing of FBR.
2. Bids are required from the owners/ authorized representatives of suitable buildings for the **Inland Revenue Service Academy, Lahore (IRSA)** to accommodate approximately 60 trainee officers.
3. Building should consist of more than 60 rooms having following facilities:
  - Rooms for single occupancy:
    - Queen size bed with best mattress Blanket and pillow; Bed sheet and pillow cover should be changed daily.
    - Wardrobe with at least six hangers;
    - Refrigerator;
    - Airconditioning; (AC invertor or if simple AC then electric Heaters in winters)
    - Wash room with basin, commode with muslim shower, wall shower with hot and cold water availability, towel, soap, bath chapple
  - Building owner should provide:
    - Room service 24/7
    - Breakfast (as per IRSA approved menu, provided with Financial Bid by the owner)
    - Dinner (as per IRSA approved menu, provided with Financial Bid by the owner)
    - Dedicated Parking for IRS Academy’s officers
4. Interested bidders shall submit the” FINANCIAL BID” online through EPAD System ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) on or before the required time and date. Tender documents containing detail terms & conditions, methodology, submission and opening dates of tender and other instructions is available at above mentioned website. Technical and financial bids consist of the following documents:
  - i. Attested copy of ownership documents of the building.
  - ii. Special Power of Attorney in case of more than one owner.
  - iii. Approved Map of the Building.
  - iv. Attested copy of CNIC of the owner/owners of the building.
  - v. Contact No. of the owner.
  - vi. Service Charges (to be mentioned in Financial Bid only)
  - vii. Affidavit to the effect that offered building/property is free of all Government financial liabilities and is not a part of any litigation what so ever.
  - viii. The owner shall be responsible to pay all types of applicable govt. Taxes. However, Income Tax and Sales Tax on rent amount will be deducted at source as per FBR/Govt. of Pakistan rules/notification.
  - ix. Filled in Bid Securing Declaration
5. Tender documents complete in all respects should be submitted on PPRA E-PAD ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) on or before **02-04-2026** at **11:00** hrs. Hard copy will not be entertained. The bids shall be opened on the same day at 11:30 hrs. IRSA reserves the right to accept or reject any or all bids or proposals as per PPRA rules.

## **SECTION II: INSTRUCTION TO BIDDERS (ITBs)**

### **INTRODUCTION**

1. Scope of Bid	1.1	The Inland Revenue Service Academy, Lahore, as indicated in the <b>Bid Data Sheet (BDS)</b> invites Bids for the provision of Services (Hiring of Building for Rent) as specified in the BDS and <b>Section-III-Technical Specifications &amp; Schedule of Requirements</b> . The successful Building Owner will be expected to provide the building for residential purpose as stated in the <b>BDS</b> .
2. Source of Funds	2.1	Source of funds is referred in Clause-2 of Invitation for Bids.
3. Eligible Bidders	3.1	A Bidder may be neutral person, company or firm or public or semi-public agency of Pakistan, or any combination of with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.
	3.2	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Inland Revenue Service Academy, Lahore.
	3.3	Verified copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
	3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Inland Revenue Service Academy, Lahore and in line with any instructions issued by the Authority.
	3.5	The invitation for Bids is open to all prospective suppliers, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by their respective national incorporating agency or statutory body established for that particular trader business.
	3.6	A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they: a) Are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Inland Revenue Service Academy, Lahore to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the goods to be purchased under this Invitation for Bids. b) Have controlling shareholders in common; or c) Receive or have received any director in direct subsidy from any of them; or d) Have the same legal representative for purposes of this Bid ; or e) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Inland Revenue Service Academy, Lahore regarding this Bidding process; or f). Submit more than one Bid in this Bidding process.
	3.7	A Bidder may be ineligible if– a) He is declared bankrupt or, in the case of company or firm, in solvent;

		<ul style="list-style-type: none"> <li>b) Payments in favor of the Bidder issues pended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;</li> <li>c) Legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;</li> <li>d) The Bidder is convicted, by a final judgment, of any offence involving professional conduct;</li> <li>e) The Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices or performance failure or due to breach of bid securing declaration.</li> <li>f) The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them</li> </ul>
	3.8	Bidders shall provide to the Inland Revenue Service Academy, Lahore evidence of their eligibility, and proof of compliance with the necessary legal requirements to carry out the contract effectively.
	3.9	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Inland Revenue Service Academy, Lahore shall reasonably request.
	3.10	Bidders shall submit proposals relating to the nature, conditions and modalities of sub- contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.
<b>4. One Bid per Bidder</b>	4.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	4.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.
	4.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
<b>5. Cost of Bidding</b>	5.1	The Bidder shall be at all costs associated with the preparation and submission of its Bid, and the Inland Revenue Service Academy, Lahore shall in no case be responsible or liable for those costs, regardless of the conductor outcome of the bidding process.

## **B. BIDDING DOCUMENTS**

6. Contents of Bidding Documents	6.1	<p>The goods/items required, bidding procedures, and terms and conditions of the contract are prescribed in the Bidding Documents. In addition to the Invitation to Bids, the Bidding Documents which should be read in conjunction with any addenda issued in accordance with ITB8. 2 include:</p> <p><b>Section I-</b> Invitation to Bids</p> <p><b>Section III-</b> Instructions to Bidders (ITBs)</p> <p><b>Section III-</b> Bid Data Sheet (BDS)</p> <p><b>Section IV-</b> Technical Specifications, Schedule of Requirements</p> <p><b>Section V-</b> Forms – Bid</p> <p><b>Section VI-</b> General Conditions of Contract (GCC)</p> <p><b>Section VII-</b> Special Conditions of Contract (SCC)</p> <p><b>Section VIII-</b> Contract Forms</p>
	6.2	The number of copies to be completed and returned with the Bid is specified in the <b>BDS</b> .
	6.3	The Inland Revenue Service Academy, Lahore is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Inland Revenue Service Academy, Lahore or the signed PDF version downloaded from the website of the Procuring Agency PPRA. However, Inland Revenue Service Academy, Lahore shall place the PDF version to facilitate the bidder for filling the forms.
	6.4	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will bear the Bidder's risk and may result in the rejection of its Bid.
7. Clarification of Bidding Documents	7.1	A prospective Bidder requiring any clarification of the Bidding Documents may notify the Inland Revenue Service Academy, Lahore in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the <b>BDS</b> .
	7.2	The Inland Revenue Service Academy, Lahore will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB22.1</b> . However, this clause shall not apply in case of alternate methods of Procurement.
	7.3	Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source. In case of downloading the Bidding Documents from the website of Procuring Agency, the response of all such queries will also be available on the same link available at the website.
	7.4	Should the Inland Revenue Service Academy, Lahore deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under <b>ITB 8</b> .
	7.5	If indicated <b>in the BDS</b> , the Bidder's designated representative is invited at the Bidder's cost to attend pre-Bid meeting at the place, date and time mentioned <b>in the BDS</b> . During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.
	7.6	Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as

		a result of the pre-Bid meeting shall be made by the Inland Revenue Service Academy, Lahore exclusively through the use of an Addendum pursuant to ITB8. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
<b>8. Amendment of Bidding Documents</b>	8.1	Before the deadline for submission of Bids, the Inland Revenue Service Academy, Lahore, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-Bid meeting may modify the Bidding Documents by issuing addenda.
	8.2	<p>Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to <b>ITB6.1</b> and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Inland Revenue Service Academy, Lahore.</p> <p>The Inland Revenue Service Academy, Lahore shall promptly publish the Addendum at the Procuring Agency’s web page identified in the BDS:</p> <p>Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p>
	8.3	<p>To give prospective Bidders reasonable time in which to take an addendum/ corrigendum in to account in preparing their Bids, the Inland Revenue Service Academy, Lahore may at its discretion, extend the deadline for the submission of Bids:</p> <p>Provided that the Inland Revenue Service Academy, Lahore shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.</p>

## **C. PREPARATION OF BIDS**

<b>9. Language of Bid</b>	9.1	The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Inland Revenue Service Academy, Lahore shall be written in the English language unless specified in the Bid Data Sheet (BDS). Supporting documents and printed literature furnished by the Bidder in other language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS, in which case, for purposes of interpretation of the Bidder, the translation shall govern.
<b>10. Documents and Sample(s) Constituting the Bid</b>	10.1	The Bid prepared by the Bidder shall constitute the following components:- a) Form of Bid and Bid Prices completed in accordance with ITB13 and 14; b) Documentary evidence established in accordance with ITB12 that the Bidder is eligible and/or qualified for the subject bidding process; c) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and d) Any other document required in the BDS
<b>11. Documents Establishing of Goods and Related Services and Conformity to Bidding Documents</b>	11.1	Pursuant to ITB10, the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and related services which the Bidder proposes to deliver.
	11.2	The documentary evidence of conformity of the related services to the Bidding Documents may be in the form of literature, drawings, and data, and shall consist of a detailed description of the essential technical specifications and characteristics of the building;
<b>12. Documents Establishing Eligibility and Qualification of the Bidder</b>	12.1	Pursuant to ITB10, the Bidder shall furnish, as part of its Bid, all those documents establishing the Bidder's eligibility to participate in the bidding process and/or its qualification to perform the contract if its Bid is accepted.
	12.2	The documentary evidence of the Bidder's qualifications to perform the contract if its Bid is accepted shall establish to the satisfaction of Inland Revenue Service Academy, Lahore that: <ul style="list-style-type: none"> <li>• The Bidder has the technical capability necessary to perform the Contract, meets the qualification criteria specified in BDS.</li> <li>• That the Bidder meets the qualification criteria listed in the Bid Data Sheet.</li> </ul>
<b>13. Form of Bid</b>	13.1	The Bidder shall fill the Form of Bid furnished in the Bidding Documents. The Bid Form must be completed without any alterations to its format and no substitute shall be accepted.
<b>14. Bid Prices</b>	14.1	The Bid Prices and discounts quoted by the Bidder in the Form of Bid and in the Price Schedules shall conform to the requirements specified below in ITB Clause14 or exclusively mentioned hereafter in the bidding documents.
	14.4	The Bid price to be quoted in the Form of Bid in accordance with ITB14. 1 shall be the total price of the Bid, excluding any discounts offered.
<b>15. Bid Currencies</b>	15.1	Prices shall be quoted in Pakistani Rupees.
<b>16. Bid Validity Period</b>	16.1	Bids shall remain valid for a period of one year, BDS after the Bid submission deadline prescribed by the Procuring Agency. A Bid valid for a shorter period shall be rejected by the Inland Revenue Service Academy, Lahore as non-responsive. The period of Bid validity will be determined from the complementary bid securing instrument i.e. the expiry period of bid security or bid securing declaration as the case may be.
	16.2	Under exceptional circumstances, prior to the expiration of the initial Bid validity period, the Inland Revenue Service Academy, Lahore may request the Bidders' consent to an extension of the period of validity of their Bids only once, for the period

		not more than the period of initial bid validity. The request and the Bidders responses shall be made in writing or in electronic forms that provide record of the content of communication. The Bid Security provided under ITB17 shall also be suitably extended. A Bidder may refuse the request without forfeiting its Bid security or causing to be executed its Bid Securing Declaration. A Bidder agreeing to the request will not be required nor permitted to modify its Bid, but will be required to extend the validity of its Bid Security or Bid Securing Declaration for the period of the extension, and in compliance with ITB17 in all respects.
	16.3	If the award is delayed by a period exceeding Sixty (60) days beyond the expiry of the initial Bid validity period, the contract price may be adjusted by a factor specified in the request for extension. However, the Bid evaluation shall be based on the already quoted Bid Price without taking in to consideration on the above correction.
<b>17. Bid Security or Bid Securing Declaration</b>	17.1	The Bidder should submit Bid Security Rs. 500,000 (Rupees Five Lacs) in the form of a bank draft or pay order alongwith Financial proposal
<b>18. Alternative Bids by Bidders</b>	18.1	Bidders shall submit offers that comply with the requirements of the Bidding Documents, including the basic Bidder's technical design as indicated in the specifications and Schedule of Requirements. Alternatives will not be considered, unless specifically allowed for in the BDS. If so allowed, ITB 18.2 shall prevail.
<b>19. Withdrawal, Substitution and Modification of Bids</b>	19.1	Before bid submission deadline, any bidder may withdraw, substitute, or modify its Bid after it has been submitted by sending a written notice, duly signed by an authorized representative, and the corresponding substitution or modification must accompany the respective written notice.
	19.2	Bids requested to be withdrawn in accordance with ITB shall be returned unopened to the Bidders
<b>20. Format and signing of Bid</b>	20.1	The Bidder shall prepare an original and the number of copies of the Bid as indicated in the BDS, clearly marking each "ORIGINAL" and "COPY," as appropriate. In the event of any discrepancy between them, the original shall prevail: Provided that except in Single Stage One Envelope Procedure, the Bid shall include only the copies of technical proposal.
	20.2	The original and the copy or copies of the Bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to sign on behalf of the Bidder. This authorization shall consist of a written confirmation as specified in the BDS and shall be attached to the Bid. The name and position held by each person signing the authorization must be typed or printed below the signature. All pages of the Bid, except for un-amended printed literature, shall be initialed by the person or persons signing the Bid.
	20.3	Any interlineations, erasures, or over writing shall be valid only if they are signed by the person or persons signing the Bid.

## **D. SUBMISSION OF E-BIDS**

<b>21. Sealing and Making of Bids</b>	<b>21.1</b>	Technical of financial bids will only be accepted and entertained if it is uploaded on EPADs. No bid will be accepted if submitted through any other means.
<b>22. Deadline for submission of Bids</b>	<b>22.1</b>	Bids shall be received by the Procuring Agency not later than the date and time specified in the BDS.
	<b>22.2</b>	The Inland Revenue Service Academy, Lahore may, in exceptional circumstances and at its discretion, extend the dead line for the submission of Bids by amending the Bidding Documents in accordance with ITB8, in which case all rights and obligations of the Inland Revenue Service Academy, Lahore and Bidders previously subject to the deadline will thereafter be subject to the new deadline
<b>23. Late Bids Evaluation</b>	<b>23.1</b>	The Inland Revenue Service Academy, Lahore shall not consider for evaluation any Bid that arrives after the deadline for submission of Bids, in accordance with ITB22
	<b>23.2</b>	Any Bid received by the Inland Revenue Service Academy, Lahore after the deadline for submission of Bids shall be declared late, recorded, rejected and returned unopened to the Bidder.
<b>24. Withdrawal of Bids</b>	<b>24.1</b>	A Bidder may withdraw its Bid after it has been submitted, provided that written notice of the withdrawal of the Bid is received by the Inland Revenue Service Academy, Lahore prior to the deadline for submission of Bids.
	<b>24.2</b>	Revised bid may be submitted after the withdrawal of the original bid in accordance with the provisions referred in ITB21.

## E. OPENING AND EVALUATION OF BIDS

25. Opening of Bids	25.1	The Inland Revenue Service Academy, Lahore will open all Bids, in public, in the presence of Bidders' or the representatives. Who choose to attend, and other parties with a legitimate interest in the Bid proceedings at the place, on the date and at the time, specified in the <b>BDS</b> . The Bidders' representatives present shall sign a register as proof of their attendance.
	25.6	In case of Single Stage Two Envelope Procedure, the Inland Revenue Service Academy, Lahore will open/download the Technical Proposals in public at the address, date and time specified in the <b>BDS</b> in the presence of Bidders' designated representatives who choose to attend and other parties with a legitimate interest in the Bid proceedings. The Financial Proposals will remain unopened until the specified time of their opening.
	25.7	The envelopes holding the Proposals shall be opened at a time, and the following read out and recorded: (a) the name of the Bidder; (b) whether there is a modification or substitution; (c) the presence of a Bid Security, if required; and (d) any other details as the Inland Revenue Service Academy, Lahore may consider appropriate.
	25.8	Bidders are advised to send in a representative with the knowledge of the content of the Bid who shall verify the information readout from the submitted documents. Failure to send a representative or to point out any un-read information by the sent Bidder's representative shall indemnify the Inland Revenue Service Academy, Lahore against any claim or failure to readout the correct information contained in the Bidder's Bid.
	25.9	No Bid will be rejected at the time of Bid opening except for late Bids which will be returned unopened to the Bidder, pursuant to <b>ITB23</b> .
	25.10	The Inland Revenue Service Academy, Lahore shall prepare minutes of the Bid opening.
