TENDER FOR OPERATION OF CHINA CHAKKI/DISK MILL AT PMDC SALT MINES, WARCHA.

E- tenders are invited from the interested parties, registered with Federal Board of Revenue (FBR), having active Taxpayer List of (NTN & STRN) and Punjab Revenue Authority (PRA) having active status of (NTN) for operation of our one China Chakki/Disk Mill for production of special powder salt and also to carry out other allied works, one China Chakki/Disk Mill for production of special powder salt also to carry out other allied works, such as special packing of grinded salt for export purpose and transportation of the said salt from Godown upto 1.5 KM (Including loading & un-loading) for a period of one year for PMDC Salt Mines, Warcha. Detail of work to be done are as under:

1.	Grinding Good Quality Pink Salt at China Chakki/Disk Mill, Packing in bags with liner (liner to be inserted in to bag by contractor) and placing the bag in Godown in proper arrangement.	7500
2.	Sorting Good Quality Pink Salt to Depot/Yard and shifting to China Chakki.	7500
3.	Special Packing of Salt in 25 Kg and 50 Kg Bags for export purposes	as per requirement
4.	Transportation of grinding salt from China Chakki/Disk Mill to Packing Place upto 1.5 KM (including loading & un-loading)	as per requirement

GENERAL TERMS & CONDITIONS:

1. Electronic bid on (single stage-single envelope method) must be submitted on EPAD on or before **09.04.2026 at 11:00 AM** which will be opened on the same day at **11:30 AM** in the presence of bidder or their authorized representative who desire to participate at PMDC Head office, Islamabad.
2. Bid Money of Rs. **300,000/-** in the form of pay order/demand draft made in the name of Pakistan Mineral Development Corporation (PMDC) Head Office, Islamabad on account of bidder from any scheduled bank shall accompany the bid/tender. Tender with less or without bid money



(in the form of pay order/demand draft) or pay order/demand draft without the name of bidder shall not be considered.

3. Each bidding document should be duly signed and stamp by the bidders.
4. Tender without bid money shall not be considered.
5. Tender with over-writing, cutting or conditional, or optional rates or by fax shall not be accepted. Unsigned tenders shall not be considered.
6. Tender should remain valid for 90 days period from the date of opening of tender.
7. The bidders will be required to quote rates on prescribed forms attached. The bidders will quote rates against each item. Rates must be inclusive of all taxes.
8. The bidder individual/firm should have minimum 5 years' experience of operating any grinding Plant & have to submit experience certificate (copy of work orders) to this office.
9. Successful bidder will be required to deposit security money equal to 10% of the total value of the contract before the signing of agreement. The earnest money deposited with the tender, will be converted into the part of his security money. The security money will be refunded only on successful completion of the contract. The contractor will not be entitled for any profit/interest on this security deposit.
10. The successful bidders will be required to sign an agreement with PMDC within 10 days of acceptance of his tender. If the agreement is not signed by the party within stipulated time limit or he fails to start work within 07 days of award of contract, the agreement will be cancelled and the earnest money/ security deposit forfeited.
11. The Contract will be for a period of one year starting from contract signing date and can be extended with mutual consent with possible changes backed with verifiable price indexes
12. The quantity of each category mentioned in this tender can be increased or decreased by 15 % the project management according to the demand.
13. In case the contractor fails to grind/crush the salt according to the assigned target or he fails to pack and transport the salt to 1.5 KM packing place, penalty of Rs.200/- per tonne will be imposed for each default. The Project Manager, Warcha shall be at liberty to get the work done at the risk and cost of the contractor.
14. In case the contractor fails to fulfill all or any of his contractual obligation under the agreement his contract will be liable for cancellation and security money forfeited.



15. The contract will be liable to be cancelled in case of any dishonesty on the part of the contractor or on part of any of his people (s) to be engaged by him.
16. The Powder Salt produced will be considered in terms of Nos. of bags and each bag will properly be weighed on manual scale to be made available by the management.
17. The contractor will be penalized on production of any sub-standard material. In case of inferior quality salt. Production will be accepted and no payment will be made.
18. The manpower engaged by the contractor shall not be treated the employees of PMDC in any case. The contractor being employer of these employees shall be bound to fulfill all legal obligations in respect of these workers and specifically the minimum wages, workmen compensation, EOBI etc.
19. In case of fatal accident, workmen compensation will be made by PMDC out of the fund maintained at the project for the purpose of payment of compensation of the contractors' employees. The contractor under this agreement will be bound to contribute on prescribed rate per tonne basis at par with Raising contractors.
20. Quality & Quantity of product will be the responsibility of the contractor.
21. Any rejection of the grinded salt from customers/PMDC quality section will be charged to the contractor at prevailing price exclusive of taxes.
22. All Taxes will be deducted as per rules. The contractor shall also be responsible for paying Govt. taxes/levies payable directly.
23. All bidders should be registered with PRA and FBR department. All Govt. taxes will be applicable i.e. GST (PRA, Income Tax etc.) The rate quoted should be inclusive of all taxes. The bidder will submit copies of registration certificate with FBR, PRA & Income Tax department on the date opening of tenders. PMDC will only accept changes in PST/GST if announced by Govt. of Pakistan. Any changes in other taxes will be responsibility of contractor.
24. PMDC shall have the right to cancel the bid and subsequent award of contract, if any information is revealed at any stage which is contrary to the above-mentioned terms and conditions of this tender document.
25. Contractor/ firm must be of sound financial health and shall provide certified bank statement covering last 12 months (from the date of submission of bid).
26. Contractor/firm must provide a list of names of all of its owners, directors and management team along with their brief resumes.
27. Contractor/firm or any its subsidiary companies or any of its directors/owners or any of their relatives (parents, children, and brother, sister) should not be under litigation with PMDC in any local or foreign court of law.



28. Contractor will ensure to follow the PMDC HSE policy/rules in true essence and will address the HSE team observations on priority. HSE violation can lead to the termination of contract with forfeiting security.
29. Contractor/firm or any its subsidiary companies or any of its directors/owners of their relatives (parents, children, brother, sister) should not have any ongoing, unresolved business dispute with PMDC. PMDC shall be the sole judge of fulfillment of this requirement.
30. In case of any dispute regarding this purchase order, the same will be resolved between the relevant parties through negotiations. If negotiations shall fail, then matter will be referred to the Arbitrator. The MD, PMDC will act as sole Arbitrator as per Arbitration Act, 1940. Decision/award of Arbitrator will be final and binding on the both parties.
31. **TAXES:** Taxes shall be recovered as per Govt. Tax Rules. The contractor shall also be responsible to pay Govt. Taxes/levies payable directly.
32. **FAILURE & TERMINATION:** In the event of failure to complete task as per specifications and within the stipulated period of delivery, security money deposited by the bidder shall be forfeited.
33. I agree to the above term and conditions and give my acceptance.
