Tenders will only be issued to the scrutinized / security wise cleared contractors. The tenders must be received in the office of acceptance officer by **06 Apr 2026** till **1150 hrs** and will be opened on **1200 hrs** on **06 Apr 2026**.

NOTE: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of DI&E (E-in-Cs br GHQ) is outstanding against them.

- All contractors will certify in writing that they are registered with **Pakistan Engineering Council (PEC)** and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply and will not be considered for issuance of tender documents.
- Contractors born on approved list of MES in Cat 'B' 'C' and 'D' above also having experience should only apply.
- Contractors who desire may be present at the time of opening of tenders.
