## NOTICE OF TENDER

1. Applications for pre-qualification of contractors / firms are invited by GE (A) Comds Rwp for pre-qualification and issue of the tenders for the following works: -

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor born on approved list of MES in categories 'A', 'B', 'C', 'D', 'E' and also having experience of this type of works should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the rights to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
