





**SPECIAL CONDITION**  
**Breach of Security**

The contractor shall acquaint himself and shall always be deemed to have acquainted himself with the provision of the Official Secret Act 1923 and other security and shall abide by and confirm to these. He will further ensure and be personally responsible for ensuring etc that his employees (Supervisory Staff and Labors etc) are acquainted with the abide by all such rules and orders. Breach of the said provisions on the contractor or his employees in addition to any other liability under law. Officer and completion of remaining of the work at his risk and cost by any other agency which the Accepting Officer may consider suitable.

The Engineer-in-Charge shall at his discretion has the right to issue passes to control admission of the contractor his staff work people and agents to the site of the work or of any part thereof and the contractors shall on demand by the Engineer-in-Charge, submit list of work people etc employed on the work and shall satisfy the Engineer-in-Charge as to the genuineness of such personnel. Passes shall remain the property of Government and shall be returned at any time on demand by the Engineer-in-Charge and in all cases on completion of the work.

Officer's detailed by the Ministry of Defence, will have the right to enter the premises to exercise check/periodical inspection of firm record relating to defence contracts to ensure that all classified correspondence is being kept and maintained properly.

The contractor shall ensure that during construction and after completion of work, no information of any kind shall be divulged to any source without clearance and permission of DW&CE. Non completion of this Clause will take the defaulting contractors liable to prosecution.
