

Following terms and conditions are necessary for the Govt. contractors to fulfill before considered eligible issuing tender forms by the Postmaster General Southern Punjab Multan.

There is no guarantee to any contractor that total cost of work to be executed will be same as mentioned below.

3)- The PAK PWD Schedule of rates 2022 for Building, Road, Water Supply, Sanitary Works, Public Health andfor Electric Works, should be followed by the Govt. Contractors while giving tender rates for the above-mentioned works.

4)- Amendment issued by the Authority PAK PWD in the rate of any items after opening of tenders shall not be considered in any case.

5)- No escalation due to increase in rate of any building material shall be given on all the approved rates thus approval shall remain firm and final throughout the currency of this contract.

6) - The electronic bids must be submitted by using EPADS on or before 20-04-2026. Manual bid shall not be accepted, electronic bid will be opened on 21-04-2026 at 11.30 hours in Chamber of Postmaster General in the presence of contractors / their representatives who wish to participate.

7)- No Tender will be considered unless it is supported by the original receipt of earnest money deposited in Post Office or CDR for many bank according to the amounts mentioned at para 2. - 8)- No conditional or by Post tender will be accepted. Lowest rates of each item will be accepted and will be applied for each zone during for year 2025-26 and until the tenders for next year are called.
- 9)- Extra ordinary high or low rates will not be considered.
- 10)- The Postmaster General Southern Punjab Multan reserves the right to take appropriate action as deemed fit in case of tenderer who show very high or very low rates, which are incapable of giving proper analysis in support of the correctness of rates thus quote.
- 11)- The Postmaster General Southern Punjab Multan reserves the right to accept or reject any or all tender without assigning any reason thereto.

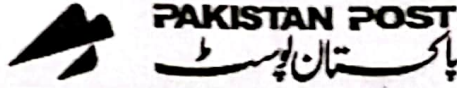
