SPECIAL CONDITION OF CONTRACT (SCC) AND OTHER TERMS AND CONDITIONS

1. The tenderer should indicate the National Tax and G.S.T. number in his offer.
2. The payment will only be made after the presentation of the sale tax invoice along with the bill.
3. For firms related to contract Services should be registered with PRA before payment otherwise payment will be made as per PRA Rules.
4. Tenderer should be registered suppliers who are on active taxpayer list (ATL) of FBR. If the Tenderer is not on active taxpayer list (ATL) the payment will not be made till his appearance on ATL of FBR.
5. All pages of Tender Documents must be signed and attested by bidder.
6. Bidder/Tenderer should attach copy of his/her CNIC.
7. If there is a discrepancy between the unit rate and the total price in the price schedule, resulting from the incorrect multiplication of the unit rate by the quantity. The unit rate quoted shall be corrected.
8. Bidder/Tenderer should attach copy of his/her CNIC.
9. Only PEC registered firms in C-5 category (or above) having relevant specialty code are eligible to apply.
10. CDR/ Banker Cheque / Performance Guarantee can be detained by the Pakistan Mint for one year.
11. Advance payment upto 15% of quoted price may be given to the Contractors against the Bank Guarantee.
12. The Contractor has to dismantle already existing old wall.
13. Any old material like brick or steel provided by Pakistan Mint will be deducted from the final bill.
14. The Bidder / Contractors acknowledges that they have physically visited the site and had familiarized with the Construction of required Civil work including the materials required.
15. The Bidder should have completed at least two such kind of works in last three years.
16. In case of late Completion of Work Liquidated damage at the rate of 2% per month upto a maximum at 10% can be imposed on prorata basis. It will be carried out in accordance with PPRA National Standard Bidding documents GCC Clause 25,26,27,28.
17. No interest will be paid on any delay in payment (GCC Clause 19.3).
18. The Director General, Pakistan Mint reserves the right in the Public Interest:-
 - a. To accept or reject the part or whole of the tender without assigning any reason.
 - b. To waive off any of the condition /Specification in the tender/Purchase Order.
 - c. To withdraw any or all items, amend or change the quantity of stores included in this Tender while placing the order.
 - d. Tender can be rejected any or all the bids prior to acceptance of the bids as per PPRA Rules.
