2. INSTRUCTIONS TO BIDDERS (ITB)

2.1 Procurement Method

Open Competitive Bidding

Single Stage – Two Envelope procedure

2.2 Eligibility (Rules 18 & 19)

- Be registered with FBR (NTN & ATL)
- Not be blacklisted by any Government organization
- Have experience in supply of stationery items

2.3 Bid Validity

- 90 days from bid opening date

2.4 Bid Security (Rule 25)

- 2% of Estimated Cost
- In shape of CDR / Pay Order / Bank Guarantee
- Valid for 28 days beyond bid validity

2.5 Submission of Bids (Rule 30)

- One sealed envelope clearly marked:
“Bid for Procurement of Stationery – WWB”
- Late bids shall be rejected

2.6 Bid Opening (Rule 28)

- Public opening at specified dated **22-04-2026 & Time 02:30 PM**
- Representatives may attend
