
Bidding/Tender documents can be downloaded from EPADS free of cost. Bidders must submit their bids through E-Pak Acquisition & Disposal System (EPADS). Bid must be accompanied by scanned copy of Bid Security in the form of CDR/Pay order, in favour of DAO, Pakistan Railways Sukkur amount as mentioned below, whereas, bid security in original shall be submitted in the office of Divisional Accounts Officer Pakistan Railways Sukkur along with other necessary documents as stated in bidding documents upto 11:00 hours. Bids must be uploaded on EPADS before 11:00 hours on **22.04.2026**.

e-bidding documents as per regulations, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at (www.eprocure.gov.pk)

The electronic bids, must be submitted by using EPADS on or before 11:00 hours on **22-04-2026** at Divisional Accounts Officer, Sukkur. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at 11:30 hours.
