INVITATION FOR BIDS

District Judiciary (East & West), Islamabad invites electronic bids from reputable Contractors/Firms registered with PPIB, PEC, FBR, and other relevant authorities for the project "Design, Supply, Installation, Testing, Commissioning and Operation & Maintenance of Net Billing Based 709.2 kW On-Grid Solar PV System" for District Judicial Complex, G-11/4, Islamabad, and Family Courts Complex, G-10/1, Islamabad.


Bidding will be conducted through Single Stage – Two Envelope procedure via EPADS (PPRA). Bidding documents containing detailed terms and conditions are available for registered bidders on EPADS at www.eprocure.gov.pk and also available on official website www.dsci.gov.pk.

Bids, along with all required documents as specified in the bidding documents, must be submitted electronically through EPADS on or before **30.04.2026** at 10:00 am. Each bid must be accompanied by a bid security amounting to **PKR 4,300,000/-** in the shape of Demand Draft/Pay Order in favor of District & Sessions Judge (West), Islamabad. The original bid security must be submitted at the office of the undersigned before the closing time, failing which the bid shall be declared non-responsive.

A pre-bid meeting shall be held on **23.04.2026**, and all interested bidders are required to attend.

Technical bids will be opened on the same day at 10:30 am in the presence of bidders or their authorized representatives who choose to attend at the Conference Hall, A-Block, District Judicial Complex, G-11/4, Islamabad.

Incomplete or late bids shall not be entertained. In case of a public holiday, law and order situation, unforeseen circumstances, or any technical issue in EPADS on the scheduled date, the bids shall be opened on the next working day at the same time and venue without further notice.
