

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their valid registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor borne on approved List of MES in Categories 'A', 'B', 'C', 'D', & 'E', and also having experience of this type should only apply.

5. Contractor who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33(i) of PPRA Rules.
