

ANNUAL TENDER / CLOSE FRAME WORK AGREEMENT FOR PROCUREMENT OF DENTAL MEDICAL STORE, DISPOSABLES, MEDICINES, DENTAL IMPLANTS AND ELECTRO MEDICAL EQUIPMENT FOR ARMED FORCES INSTITUTE OF DENTISTRY (AFID) AND MILITARY DENTAL CENTRES (MDCs) / MOBILE DENTAL UNITS (MDUs), FINANCIAL YEAR 2026-27



1. Sealed bids are invited from local importers / authorized suppliers for Dental Medical Store, Disposable and Medicines, Dental Implants and Electro Medical Equipment's for Armed Forces Institute of Dentistry (AFID) and Military Dental Centre (MDCs) / Mobile Dental Units (MDUs) for FY 2026-27, offering maximum rebate / discount on retail price of Dental Store (Expendable and Non-Expendable) including all applicable taxes. The list of items required along with terms and conditions of supply can be obtained from procurement cell (Medical Store) of Armed Forces Institute of Dentistry Rawalpindi during working hours on presentation of following documents: -

a.	Registration Letter of DGDP or DRAP	b.	FBR Registration with valid NTN & Sales Certificates
c.	Bank Statement of Last 3 months	d.	Import Certificate or Authorized Distributor Certificate
e.	Professional Tax Certificate	f.	Experience Certificate
g.	Certificate that Name of the Vendor is Present in the Active Tax Payer List	h.	FBR GST Certificate.

2. The supplier must be registered with **DGDP Army or DRAP** and should have security clearance from concerned military authorities and must not be blacklisted or associated to the blacklisted firm.
3. Only those suppliers can submit quotation who are sole agents or authorized distributors of Dental Materials / Dental items and registered for National Tax and Sales Tax with Govt of Pakistan.
4. Complete quotations (**Technical and Financial**) are required to be submitted in separate sealed envelopes to this office clearly indicating the name of supplier, date of submission and words "**Technical Quotation**" and "**Financial Quotation**" till **28 Apr 2026 at 09:30 AM**. Technical bids will be opened in Auditorium of AFID Rwp on **28 Apr 2026 at 10:00 AM** in the presence of authorized representatives of suppliers.
5. Soft data of both technical & financial quotations will also be provided to procurement cell / medical store AFID.
6. Rule 33 (1) – The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submit a bid or proposal, the ground for its rejection of all bids or proposal, but is not required to justify those grounds.
7. Country of manufacturer of **Dental Materials** should be as per standard of USA, Europe, Japan, Italy and Australia.
8. **Dental Implant, Ortho appliances, Maxillofacial plates & screws** should be as per standard of USA, Germany, Japan, Italy, Korea and Switzerland.
9. Country of manufacturer of **Disposable items / Medicines** should be as per standard of USA, Japan, Europe, Italy, Australia, Pakistan, China and Malaysia.
10. The quoted **Electro Medical Equipment** should be as per standard of USA, Japan, Germany, France, Italy, Australia and Switzerland.
11. Proper import documents including GD1, GD2 and custom challan / Tax deposit receipt will be provided with bill submission. Complete details of documents required is mentioned in terms & conditions.
12. Samples should be provided as and when required during the procurement procedure.
13. DRAP registered items will be preferred.
