4. Contractors are born on approved list of MES in categories 'A' & 'B' and also having experience of this type should only apply.

5. Contractors who desire may be present at the opening of Tenders.

6. The accepting officers reserve the right to accept or reject the Tender. Rejected Tender will be dealt with as Para 33 (i) of PPRA Rules.
