Electronic bids will be opened on [www.eprocure.gov.pk](http://www.eprocure.gov.pk). Single stage one envelope procedure will be followed for this procurement.

All e-bids must be accompanied by a Bid Security in an acceptable form amounting to **Rs. 12,583,000/-** in the form of unconditional Bank Guarantee issued by Scheduled Bank in Pakistan or Call to Deposit/ Pay Order/ Bank Draft in favour of **GM/PD DBDP (DAM PART) WAPDA** before the closing dated & time i.e 19.05.2026 at 1200 Hrs. A scan copy of bid security must be uploaded on EPADS and original must reach the office of GM/PD, DBDP Room No. 708, WAPDA House, Lahore before due date and time of bid submission. Bids submitted without Bid Security or after the specified deadline shall be declared non-responsive.
