1. Procedures of Open Competitive Bidding:

Single Stage Two envelope procedure as per PPRA rules 2004 clause 36 (b) will be adopted for tender process. Bid shall comprise of single package containing two separate envelopes each envelope shall contain separately sealed financial proposal and Technical proposal. Envelope shall be marked as "Financial Proposal" and "Technical Proposal" in bold and legible letter to avoid confusion.

The tender will be opened through E-Pads new version 2.0.

Tender documents can be obtained from E-Pads new version 2.0/PPRA Website.

The said tender notice will also be available on E-Pads, FPPRA & GEPSCO Website.

2. Who can Participate?

1. The firms must be registered/renewed for current fiscal year 2025-26 from Pakistan Engineering Council (PEC) in the relevant Category, registered with PRA for PST and also registered with FBR for income Tax with active status.
2. The firms must have prior experience (at least 05-years) of providing services for carrying out survey & preparation of route plan/profile/ Soil Investigation with complete test reports of 132 KV Transmission Line works. In proof of experience the firms are required to submit satisfactory job completion certificates issued from the previous concerned clients.
3. In case of JV as a successful bidder will have to submit performance security in Joint Bank Account, Joint active NTN in FBR & PRA also the agreement must be on judicial stamp paper of worth Rs. 3000/ attested from Notary Public is required.

3. Earnest Money.

- (i) Original Bid Security for the period of 120 days in the shape of Bank Draft issued by a scheduled bank in Pakistan Rs.0.2 million must be supplied along with technical bid.
- (ii) The successful bidder will have to submit Rs.0.5 million as performance Security in the form of CDR, Bank Draft after issuance of LOI.

4. Other Conditions.

- (i) In addition to experience the bidder has to submit documents/ company profile which prove that bidder has been involved in the survey work and soil investigation of Transmission Lines work for the last five years and has sound financial position.
- (ii) Authority letter is required on 100 rupees judicial stamp paper for Contractor representatives to receive tender documents / participation in the tender process.
- (iii) Cutting/ Overwriting is not allowed in tender documents.
- (iv) Tendered rates should be filled in figure as well as in words and tender should be signed as per general directions given in the tender documents.

5. Note.

The Department/Company reserves the rights to accept or reject the tender as per PPRA Rules. (No conditional tender will be accepted).

The contents list of required documents should be in line & readable submitted through E-PADs new version 2.0 and also in front of bidding documents.
