 - o Electronically via EPADS link all docs clear & visible scan shape &
 - o Manual Tender docs must be submit in the **Tender Room main entrance Supply Chain Management Building near PIA Head Office Karachi Airport** Pakistan. (Note Foreign bidders required to dispatch their bidding docs both Technical & Commercial bids through courier services before closing of tender date as address given in the tender docs.
3. Bids will be opened on the **same date, time, and venue i.e. 25 May 2026 at 11:00 AM.**
4. **For Pakistan based Local Bidders required to submit:**
Hard copies of bidding documents along with **original tender fee Rs. 45000/- (non-refundable) and earnest money** PKR Rs. 600,000/- (Refundable) must be submitted with the **technical bid** in a sealed envelope in form of Pay Order in favor of Pakistan International Airline Corporation Limited (PIACL)

Procedure for preparation of tender docs/envelopes :

- Bid containing Technical and Financial Proposals must be sealed with scotch tape and signed by an authorized signatory.
- Tender Reference No. date of opening, and item description must be mentioned on the front of each envelope (*mandatory*).
- Two separate sealed envelopes must be submitted:
 - **Technical Proposal:** Tender Reference No. & Supplier Name only
 - **Financial Proposal:** Tender Reference No. & Supplier Name only

1. Technical Proposal (Sealed Envelope)

The Technical Proposal must contain:

- a. Technical literature/brochures of the item along with Annexure-A (without prices).
- b. Complete specifications of item (where applicable).
- c. Item Shelf life, TDS/MSDS and any other technical literatures
- d. Expected Delivery Date of item to PIA premises.
- e. Authority Letter in the name of the participating company's representative.
- f. **Tender Fee:** PKR 45,000/- (Pay Order) if Pakistan based local suppliers participated
Earnest Money: PKR 600,000/- (Refundable) Pakistan based local suppliers participated and Pay order must be in favor of "*Pakistan International Airlines*")
(Note: Foreign /International Bidders are exempted for both Tender Fee & Earnest Money submission.
- g. Signed copy of duly filled **Schedule-A (without rates)** – mandatory.
- h. Copies of all applicable certificates and mandatory requirement checklist.

2. Financial Proposal (Sealed Envelope)

- a. Unit price and total value must be quoted in **Tender Schedule-A** (mandatory).

3. Payment Terms: NTD however bidders can mention their own payment terms.

4. Shipment Inco-Terms CFR KHI basis, however bidders can mention their own terms.

5. Name of currency must be mentioned while offering unit price in financial proposals

(Note PIACL will not be responsible for any type of delay in submission of tender by participants /bidders due to human, technical or any other reasons.

Evaluation Process

- Financial proposals shall remain sealed until issuance of the Technical Evaluation Report by the Competent Evaluation Committee.
- The evaluation report shall be published on the PPRA and EPADS website for **5–7 days**.
- Grievances, if any, may be submitted to the Central Grievance Committee via email at khijzpk@piac.aero and EPADS within the time described in PPRA Rules.

- Financial bids of only **technically qualified bidders** will be opened at a later stage.
- Financial bids of **technically disqualified bidders** shall be returned unopened.

Acceptance / Rejection of Tender

PIACL reserves the right to:

- Accept or reject any bid at any stage as per PPRA rules.
- Split the business among more than one supplier.
- Extend or cancel the tender at any stage.

FBR Registration (Mandatory for Pakistan based / Local Bidders only)

Local bidders must be registered with **FBR**, possessing valid **NTN and GST**, along with proof of tax returns for the last **three years**.

Authorized distributors must provide a valid **authorization letter from the principal** (local or foreign).

Additional Instructions (Local & Foreign Bidders)

Successful bidder shall submit **5% of total bid value** as Performance Security at the time of contract award in form of Pay Order or through Wire account in favor of Pakistan International Airline Corporation Limited (PIACL)
