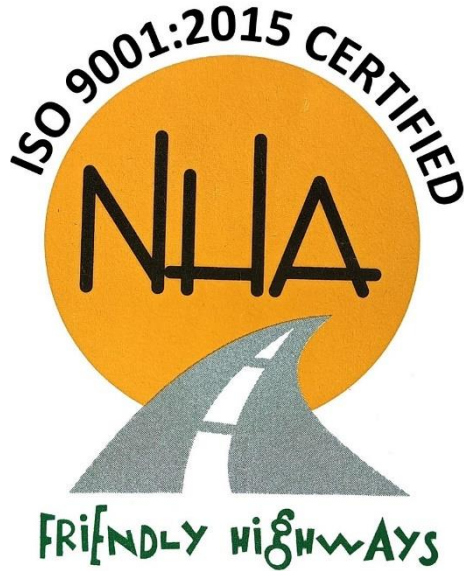

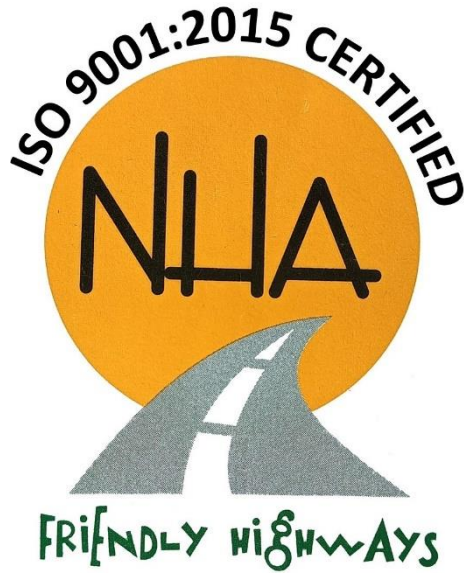

2. The open auction will be held on **Wednesday 13th May, 2026 at 12:30 hours “As is where is basis”** in the presence of representatives of bidders **at office of Dy. Director (Maintenance) NHA, Rawalpindi.**
3. Detail of terms & Conditions and application form which can be obtained from the office of Deputy Director (Maintenance) NHA Rawalpindi during the office working hours on production of demand draft/pay order of **Rs. 500 (Nonrefundable)** in favour of **National Highway Authority Receipt Account Punjab North Lahore.**
4. The interested parties are required to submit **Rs. 50,000/-** as security deposit (Refundable) in form of Pay Order / Demand Draft of any schedule bank in favour of **National Highway Authority Retention Money Account.** After approval of the case from competent authority, highest bidder will deposit 25% of bid amount on the spot in form of Cash / Pay Order / Demand Draft in favour of **National Highway Authority Receipt Account Punjab North Lahore** and remaining 75% will be deposited within a week time. The income Tax and other local taxes shall be levied as per existing rules of the Government.
5. In case, the successful bidder fails to deposit the remaining 75% amount within the prescribed time, the security deposit of the same bidder shall be forfeited and re-auction process will be adopted. No claim what so ever of such bidder will be accepted by NHA.
6. The competent Authority reserve the right to reject all bids or Proposals in accordance with PPRA Rules 2004 as amended in 2008.

1. General

Open Auction are invited from interested bidders/parties holding NTN registration, for auction of impounded material i.e. Sand, Crush, WBM and Stone Dust on basis of **“AS IS WHERE IS”**.

2. Procedure for Participations In Auction:

i. Detail of impounded material, terms & conditions and Application Form can be obtained from the office of Deputy Director (Maintenance) NHA Rawalpindi, Adjacent Byco Petrol Pump near Motorway Chowk Peshawar Road N-5, Rawalpindi on any working day during office hours on submission of a written request along with payment of **Rs.500/- (Non-Refundable)** in favour of National Highway Authority Receipt Account Punjab North Lahore and can be download from NHA & PPRA’s Web Site free of cost.

ii. Open auction will be held on **Wednesday 13th May, 2026** at **1230 Hours** by respective Committee in the presence of representatives of bidders.

3. Inspection of unserviceable / surplus items

The interested bidders/parties may inspect the impounded material on any working day during office hours at **Sangjani Weigh Station Near B-17 Multi Gardens, Islamabad**. No conveyance facility shall be provided by NHA.

4. Acceptance / Rejection of Bids

On the basis of evaluation, the successful bidder will be informed accordingly with intimation to others the grounds for rejection of their bids.

5. Mode of Payment

After completion of auction process, the successful bidder shall be bound to clear all dues and payments before taking over the impounded material at his own expenses. All transactions should be made in shape of pay order in favour of **National Highway Authority Receipt Account Punjab North Lahore**. Applicable Government Taxes shall be born/ paid by the successful bidders. If the auction items are not removed/ collected within 15 days after issuance of permission letter/gate pass, the ground rent @ 0.5% of the original sale price of the auction items per day shall be charged.
