3. The electronic bids must be submitted by using E-PADS version 2.0 on or before **11:30 Hrs.** on dated **13-05-2026**. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day / date at **12:00 Hrs.** in the o/o Resident Engineer Hydrel Power Station Nandipur Gujranwala.

TERMS & CONDITIONS:

- A) Application on original letter pad must contain complete address, contact number (PTCL/Cell).
- B) Bid Security shall be submitted only in the shape of CDR in favor of Resident Engineer Hydrel Power Station Nandipur. The name of the firm must be mentioned on the CDR. The copy of CDR shall be uploaded with Electronic Bids and original CDR must be submitted to the undersigned on the date of bid opening but not later than **11:30 hours**, otherwise bid security will not be accepted.
- C) The quoted rates must be inclusive of all applicable government taxes and no rates should be quoted which are exclusive of any tax.
- D) Discount/Rebate must be mentioned clearly on respective Bill of Quantities in terms of percentage (%) or lump-sum amount.
- E) Presentation of false/wrong documents will be strictly discouraged and their Bid Security shall be forfeited besides black listing.
- F) The Bidder shall upload PEC Registration, their certificates and details of Active Tax Payer and must show the original documents at the time of bid opening.
- G) WAPDA reserves the rights to accept/reject the bids under the provision of PPRA Rule.
