1. Government of Pakistan, Ministry of Interior & Narcotics Control, Headquarters Anti Narcotics Force Rawalpindi invites sealed bids from eligible, registered firms for supply of **Information Technology Equipment** in accordance with Public Procurement Regulatory Authority (PPRA) rules:
 - **Lot-1:** Wi-Fi Solution (various quantities)
 - **Lot-2:** Laptops and PCs (Quantity 171)
 - **Lot-3:** Printers, NAS, Switch (Quantity 26)
 - **Lot-4:** Photocopier and Scanner (Quantity 31)
 - **Lot-5:** UPS (Quantity 24).
2. Bidding documents are also available on PPRA EPADS portal and Anti Narcotics Force website. Tender detail is mentioned on E-Pak Acquisition & Disposal System (EPADS 2.0). Firms will download the said documents from EPADS 2.0.
3. Bidding will be conducted through EPADS 2.0 Single Stage One Envelope Procedure.
4. **Only firms/Contractors registered with PPRA on EPADS** as vendors are eligible to purchase bidding documents. Prices should include all applicable taxes, duties, installation and training. **Bid Money is required to be submitted in hard copy before opening of bids.**
5. The prospective bidders are also required to submit their Bids online through EPADS 2.0 before opening date, Original bids in accordance with the provisions of Rule 36(a) of Public Procurement Rules-2004 and terms & conditions defined in the bidding documents must be submitted (in sealed envelope) on the address mentioned below on or before **20-05-2026 at 10:00AM.**
6. The bids will be opened publicly on the same day **20-05-2026 at 11:00AM** in the presence of committee & bidders authorized representatives who choose to attend the opening session to be held at the office of President Tender Opening Committee, Headquarters Anti Narcotics Force Wavel Lines, Opposite Nur Khan Airbase, Chaklala Rawalpindi.
7. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
8. The firm providing undertaking and original affidavit on judicial stamp paper for non-blacklisting from any Government Department and other Semi Government of firm.
9. The Authority reserves the right to reject all the applications as per PPRA Rules-2004.
10. Documents required to be submitted by the firm/ company are as under:-
 - a. Registration certificate of FBR for GST & NTN.
 - b. Certificate of sound financial position of firm with last one year bank statement.
 - c. Details of previous five years work (Experience details).
 - d. Details of equipments, machinery & labour held.
 - e. Certificate that there is no case of litigation firm/ company.
 - f. Firm should preferably be authorized dealer of mentioned categories in Pakistan and should have the capability to provide all types of repair/ maintenance and services to this Headquarters.
