**Major Terms and Conditions are as under: -**

- i. Bidding documents are available on PPRA at E-PADS portal only. No hard copy will be issued.
- ii. Only firms/contractors registered with PPRA on E-PADS as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-bids (by uploading PDF File) and it must be submitted online on e-Procurement System (EPADS) website i.e. <https://eprocure.gov.pk>. in accordance with Rule 36(b) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents
- iii. The prospective bidders are required to submit 2% Bid Security/Earnest Money (CDR) amounting to as above mentioned against work in favour of Cantt Executive Officer, Chaklala Cantonment Board, Saddar Murree Road Rwp, CDR must be issued from any schedule bank against firm's account. Name of Firm should be clearly mentioned on

instrument (Call Deposit/CDR). The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted **Three (03) Days** before opening of Bids.

- iv. The prospective bidders are also required to submit their Bids online through E-PADS at <https://eprocure.gov.pk> before opening date. Original bids in accordance with the provisions of Rule 36 (b) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
- v. All pages of the bid documents shall be duly signed and stamped by the bidder prior to uploading in PDF format.
- vi. Bids must be submitted online on or before 18-05-2026 at 1330 hours. Bids shall be opened on the same day at 1400 hours in the presence of the contractors/firms or their authorized representatives who may wish to attend.
- vii. In case the total bid amount is up to ten percent (10%) below the estimated cost, the bidder shall be required to submit a Call Deposit as Performance Security equal to ten percent (10%) of the estimated amount. This Performance Security shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Any bid not accompanied by the requisite Performance Security shall be rejected. The Performance Security of the successful bidder shall be released upon satisfactory completion of the project.
- viii. Quoted rates shall be inclusive of all applicable govt. (federal / provincial taxes).
- ix. The successful bidder shall be bound to execute an agreement with the procuring agency and all terms & conditions including tender notice shall be binding on him.
- x. Bidder/Contractor blacklisted by any government/semi government deptt or involved in litigation or found to be indulged in corrupt and fraudulent practices will be considered non-responsive by the procuring agency.
- xi. In case of any gazette /occasional holidays the tenders will be opened on the next working day.
- xii. The Firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
- xiii. The Cantonment Executive Officer reserves the right to reject any or all bids at any stage prior to acceptance, in accordance with Rule 33(1) of the PPRA Rules, 2004.
- xiv. Work-related information may be sought from the office of Chaklala Cantonment board.
