INVITATION FOR BIDS THROUGH EPADS

1. **Bid Identification No. Sig-Proj/LON-SDR/Tender/247(2025-26).** Pakistan Railways (PR) acting through the Project Director/Signals (LON-SDR) (the "Employer") has planned to execute the project "**Tender For Procurement, Installation, Testing & Commissioning Of 04 Tons Air Conditioners For The On-Going Execution Of Computer Based Interlocking (CBI) Works In Connection With Re-Signaling Project (Lodhran – Shahdara Bagh Section)**".
2. Project Director/Signals (LON-SDR) (The Employer) intends to invites electronic bids through E-Pak Acquisition and Disposal system (EPADS) link (www.eprocure.gov.pk) from reputable Bidder's/Supplier's on the basis of Single Stage - Two envelop bidding procedure as per PPRA rules. No bid other than EPADS will be accepted.
3. Bidding documents, containing detailed terms and conditions, can be downloaded from [https:// e-procure.gov.pk](https://e-procure.gov.pk) free of cost.
4. The bids prepared in accordance with the instructions in the bidding documents, must be submitted on EPADS as per the schedule time mentioned below. Bids submitted late will be rejected.
5. Bidder must be having valid registration with Income Tax & Sales Tax Departments and who are on Active Taxpayer list of FBR.
6. The Bidder will also upload/submit their electronic Bid (the complete scanned copy of their bid) on EPADS. **Note: EPADS Tender No. F-26041867184.**
7. The Bidder must submit Bid Security/Earnest Money amounting **Rs. 1,000,000/-**. The Bid Security can be in the shape of Call Deposit Receipt (CDR) / Banker's Cheque or Bank Guarantee (in favour of FA&CAO, PR) in accordance with form provided in the Bidding Documents. The CDR or Bank Guarantee should be issued by any schedule bank in Pakistan. The Bid Security must be submitted / delivered before closing date & time of the tender to the Office of the Project Director/Signals (LON-SDR) Headquarter, Empress Road, Lahore, Pakistan and the soft copy of CDR or Bank guarantee should be uploaded on EPADS link.

The original Bid Security must be submitted by the same deadline i.e., **12:00 P.M** on **22nd May, 2026** to the office of the Project Director/Signals (LON-SDR), Pakistan Railways, Headquarters Office, Lahore. Bids will be opened at **12:30 P.M** on the same day electronically at the aforementioned address, in the presence of the bidders' authorized representatives who choose to attend. Late submission of original bid security will not be considered and shall be rejected.
