## SECTION-I (IFEB)

1. SUKKUR ELECTRIC POWER COMPANY INVITES E-BIDS ON “**AS IS WHERE IS BASIS**” THROUGH SINGLE STAGE SINGLE ENVELOPE PROCEDURE ON NATIONAL COMPETATIVE BIDDING FROM TAX PAYER REGISTERED FIRM HAVING VALID CNIC, NTN REGISTRATION AND STRN (IF AVAILABLE) FOR SALE OF OLD UNSERVICEABLE POWER TRANSFORMERS.

4. 8. THE BIDDER WHO IS NOT BLACK LISTED / NOT DEBARRED / NOT DEFAULTED IN WAPDA / NTDC / DISCOS AGAINST ANY DISPOSAL ORDER SHALL HAVE TO PROVIDE UNDERTAKING ON NON-JUDICIAL STAMP PAPER WORTH RS. 100/- OR ABOVE IN THE OFFICE OF CHIEF ENGINEER (DEV.), PMU SEPCO SUKKUR BEFORE SUBMISSION OF TENDER.

## SECTION-II (ITB & TAC)

1. **SCOPE OF BID:** Sukkur Electric Power Company invites E-Bids for sale / Disposal of Old Unserviceable Scrap Material.
2. **SCHEDULE FOR TENDER OPENING:** Tender will be opened on 04-05-2026 at 11:00 Hrs through E-Pads PPRA in the presence of bidder's representative who wish to attend.
3. **POST BID CLARIFICATION:** Any queries or clarifications must be submitted in writing at least seven days prior to the e-bid submission deadline.
4. **SUBMISSION OF BID:** Bidders are required to submit their offer / bid on E-Pads PPRA. Bidders who submit his bid / offer in hard but the offer / bid not uploaded on E-Pad PPRA will be rejected and the same will be returned back unopened. Each Page of this tender document shall be signed and stamped by bidder.
5. **BID PRICES:** The bidders are required to quote Unit Price / Rates for complete tender exclusive of Government Taxes, 18% GST and 10% Income Tax or any other Tax levied by Government of Pakistan and will be applicable on offered bid during executive / contract of Disposal Material. Bidders are required to quote firm & final rates. No escalation will be allowed.
6. Prospective bidders are strongly encouraged to physically inspect the items / Lots at SEPCO Designated Store before submission of E-Bids. SEPCO will not be responsible for any claim regarding the condition or quantity after award.
7. **VALIDITY OF BID:** E-Bid shall remain valid for 90 calendar days from the date of bid opening. E-Bid having validity less than 90 Days will be treated as "**Non-Responsive**".
8. **BID SECURITY / EARNEST MONEY:** Bid Security / Earnest Money amounting to Pak Rs. 6,422,650/- (Refundable) valid for 120 Calendar Days in favour of Chief Engineer (Dev.) PMU SEPCO Sukkur must be submitted in an Envelope clearly marked with Tender No. Title of Procurement, date & time of tender opening before the E-Bid submission deadline in the office of Chief Engineer (Dev.), PMU SEPCO, Room: 201, 2<sup>nd</sup> Floor al Sehra Building, Minara Road near Session Court Sukkur otherwise bid will be rejected. The scan copy of bid security must be uploaded on E-Pad PPRA.
9. Bid Security in the NAME OTHER THAN MENTIONED will not be accepted and such bid will be rejected by the disposal committee during tender opening (No cash or cheque will be accepted)
10. **EVALUATION CRITERIA:** Evaluation will be carried out Lot Wise Higher Quoted Rates basis.
11. Stores will be sold "**TENDER WISE**" on "**AS IS WHERE IS BASIS**" and no Dispute thereon is entertained. Bidder not quoting rate for full Tender or less than the tender quantity pertaining to said Tender will be treated as Non-Responsive.
12. Complete Tender will be awarded to 1<sup>st</sup> Highest Bidder. In case 1<sup>st</sup> highest bidder failed to meet the tender requirements, the complete Tender will be awarded to 2<sup>nd</sup> highest bidder for which the bid of 2<sup>nd</sup> highest bidder shall be equal or above the reserve price subject to the approval from Competent Authority. SEPCO reserves the right to accept or reject any proposal or all offers.
13. **DISPUTE BETWEEN BIDDERS:** In the event of any dispute between the bidders, the dispute shall be decided by the Disposal Committee and the decision will be binding on both parties.
14. **AWARD OF TENDER:** On acceptance of offered rates by successful bidder, the remaining cost of material in shape of Pay Order / CDR (to be disposed off) will be

- deposited in favour of Chief Engineer (Dev.) PMU SEPCO Sukkur but not later than 21 days.
15. Release Order will be issued to bidder after confirmation of remaining amount from Manager (Project Financing) PMU SEPCO in respect of Chief Engineer (Dev.) PMU SEPCO account.
  16. The successful bidder will be responsible for Lifting / disposal of the awarded items / lot within 21 working days from the date of issuance of Release Order. In case of delay in the lifting of material from site, after the stipulated period, bidder will pay rental charges at 1% per day of the total bid amount excluding taxes and the same will be charged until the entire quantity awarded is removed from the site.
  17. **RECOVERY OF DAMAGES / LOSSES:** SEPCO reserves the right to Recover Damages or Losses caused to SEPCO property or personnel while removing the Lot or Lots purchased by the bidder. Store owing formation will demand due compensation from the bidder to make good such damages and bidder is bound to pay the same on demand before lifting of complete material of Lot / Lots.
  18. The bidder shall be responsible for the safe and prompt removal of scrap items. Any damage to SEPCO infrastructure shall be rectified at the bidder's expense. All removal operations must strictly adhere to SEPCO protocols, including Local Laws, Labour safety, PPE usage and environmental guidelines. Upon completion of lifting, the site must be restored to its original condition.
  19. **REJECTION OR CANCELLATION OF TENDER:** The Chief Executive Officer SEPCO reserves the rights to accept or reject any tender / bid / Lot or part thereof without assigning any reason. The CEO SEPCO can cancel the Invitation of E-Bids altogether or may extend the date and time of receiving and opening of the tender / bid / Lot and to withdraw from sale any item as advertised prior to the acceptance of any offer for such time without assigning any reason.
  20. Submission of forged, false or misleading documents shall lead to disqualification of bid and legal proceedings under applicable Law and PPRA Disposal Rules.
  21. **EXTENSION IN TIME:** If delay in submitting balance amount or lifting of material from designated store is beyond the control of bidder and it is claimed that circumstances fall under the Force Majeure clause, extension will be allowed.  
Force Majeure Means:
    - i. Act of God.
    - ii. Act of State, War or any act of the Enemy
    - iii. Lock Outs, Riots or Civil Commotion.
    - iv. Injunction granted by a Court of Competent Jurisdiction not resulting from any fault of the bidder.
    - v. Any other reason along with documentary evidence
    - vi. Provided further that the bidder shall give a notice to the purchaser within 03 days of the happening of any such event.
  22. **WEIGHTMENT / COUNTING / MEASURING:** The bidder will bear all cost to be incurred on weightment, counting, measuring, loading, labour charges, transport charges (or any other) for lifting of material. No claims or objections regarding the condition, quantity or quality of the items shall be entertained after the sale.
  23. **CONFIDENTIALITY:** The Successful bidder shall treat all documents, data and site information as Strictly confidential and shall not use or disclose any information obtained in connection with this tender for any purpose other than execution of this tender.
