Tenders will only be issued to the scrutinized contractors. The Tender must be received in the accepting office by **1130 hrs** on **21 May 2026** and will be opened at **1200 hrs** on the same date.

Note. Contractors shall provide certificate that they are not involved in any type of litigation with any Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All Contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with the PEC are ineligible to apply.

4. Contractors who are enlisted with MES in **Category D and above** may only apply.

5. Tender must be quoted on **MES Schedule of Rates 2025 and Bazar Supply schedule of Rates 2017 (where applicable)**.

6. Copies of the conditions of contracts, drawings and all other documents connected with the work can be obtained from the office of undersigned during working hours and days.

7. Contractors who desire may be present at the time of opening of the Tenders.

8. Accepting authority does have the right to accept or reject any of the tender without assigning any reason, whatsoever, as per **para 33 (1) of PPRA Rules 2004**.
