

## INVITATION TO AUCTION FOR TDAP USED VEHICLES

Trade Development Authority of Pakistan (TDAP), Karachi invites open competitive bids from interested individuals /parties / firms on [e-Pak Acquisition and Disposal System](#) (e-PADS) for sale / disposal of following official vehicles on “AS IS WHERE IS BASIS”:

Interested bidders may visit TDAP Offices mentioned above at their own cost for the inspection of vehicles till **25<sup>th</sup> May, 2026** during office hours at the addresses mentioned against each. The bidders may download the tender document from e-PADS, PPRA and Authority’s website i.e. [www.tdap.gov.pk](http://www.tdap.gov.pk), free of cost.

3. **Interested bidders are required to provide bid security in shape of a pay order/bank draft in favor of Trade Development Authority of Pakistan (TDAP), Karachi**, before the opening date and time. Any bid not accompanied by a bid security shall be considered non-responsive and shall be rejected.

4. Bids, prepared in accordance with the instructions provided in the bidding documents, must apply online through ePADS on or before **26<sup>th</sup> May, 2026 (11:00 AM)**. Bid will open on **same day at 11:30 AM**. Successful bidders will be decided through open competitive bidding process who submit online bids on the same day. Vehicles will be sold to the highest bidders provided that highest bids exceed the Reserve Price.

5. The delivery of vehicles will take place on full payment (in the form of pay order in the name of Trade Development Authority of Pakistan) otherwise the earnest money (i.e. reserve price) will stand confiscated and the auction will be termed cancel.

6. TDAP reserves the right to accept or reject any bid and to annul the bidding process and reject all the bids as per Public Procurement Regulatory Authority (PPRA) Rule-33.

7. All applicable taxes and duties shall be collected as per the law from the highest bidder apart from the bid amount.
