To get the same applicant must provide his copy of (CNIC) National Identity Card.
2. Bidding will be conducted on the basis of open auction.
3. **Bid Security of Rs. 500,000/-** (0.5 Million) refundable for Platform tickets in shape of CDR/Pay order in favour of F.A & CAO/Revenue, P.R. Lahore must be delivered at the time of auction.
4. Successful bidder will pay/deposit 30% of the bid money within 7 days of the issuance of acceptance of bid by the Divisional Superintendent, Lahore. In case of failure to deposit 30% advance bid money within stipulated period, the bid security will be forfeited and 2<sup>nd</sup> highest bidder will be asked to deposit 30% amount of his bid, if considered reasonable by the administration. In case the 2<sup>nd</sup> highest bidder also fails to deposit 30% advance bid money, his security money will also be forfeited.
5. Every participant will have to give combined offer against above said stations.
6. The said contracts will be valid for a period of **One year** and will be extendable for further period of **One year** on 15% enhanced rate subject to clearance of all outstanding dues (rental charges & Withholding tax) as well as satisfactory performance of licensee with mutual consent of both parties.
7. The Parties against whom there is any outstanding, in any shape exists, or who are involved in litigation or blacklisted against Pakistan Railways will not be considered / entertained for the said projects.
