

2. The rate must be provided in **Rupees (Rs.) on lump sum basis including all applicable taxes**, (such as GST, SST of SRB, E-Stamp and Income Tax etc.) related to and connected with the completion of work.
3. The validity of the quotation must be for a period of **60** days.
4. No advance payment & extra mobilization charges will be provided as per KS&EW policy / rules.
5. Payment will be release after satisfactory completion of all assigned work after Acceptance by Project Officer / Ship Staff.
6. The successful Bidder shall provide the copy of challan and revenue stamp, of value at the rate of Thirty Five (35) Paisa per every Hundred Rupees or part thereof of the amount of the Contract, or at the prevailing rate as specified by the Government of Province of Sindh. Further as per Government of Sindh Board of Revenue notification all judicial and non-judicial stamp paper of the denomination of Rupee Five Hundred and above shall be exclusively on e-stamp.
7. Performance Bond / Bank Guarantee @ 5% of estimated value of Contract will be submitted by Sub-Contractor in form of Bank Draft / Cheque or 5% amount of each bill/invoice withheld for 06 Months by KS&EW.
8. Sub-Contractors are advised to visit KS&EW to validate / physical checking of the work and obtain all information and details from PO (Gunboat) which they deem necessary for tendering and proper execution of work, on any working day (from Monday to Friday) 0900 hours to 1600 hours before bidding.
9. Pre-Qualification Form attached for newly interested firms / not enlisted / pre-qualified with KS & EW.
10. All subject work will be done as per the Instructions of PO(Gunboat).
11. All skilled & unskilled workforce and all necessary tools, equipment, quality, health, safety, security, SOPs (penalty of Rs.10,000/- for each deviation will be imposed) to carry out the subject work shall be arranged by the Sub-Contractor.
12. The Sub-Contractor is responsible for the medical treatment cover of his workforce in case of any accident. In case of any fatal accident, the Sub-Contractor will be liable to pay an amount of Rs 1.0 M (Rupees One Million) to family of the deceased.
13. Quotation to be submitted in the office of the undersigned on or before 1100 hours by 02-06-2026 and will be opened on the same date (i.e. 02-06-2026) at 1130 hours in the office of Development & Sub-Contract.
