1. The auction shall be conducted strictly on “as is where is” and “as is what is” basis.
2. The procurement shall be carried out under **Single Stage – One Envelope Procedure** through **EPADS v2.0**, in accordance with **PPRA Rules, 2004 (as amended)** and **Disposal of Public Assets Regulations, 2024**.
3. All bidders must be **registered with Federal Board of Revenue (FBR)** for Income Tax and Sales Tax and must appear on the **Active Taxpayer List (ATL)**.
4. The quoted rates shall be **exclusive of all applicable taxes**, which shall be payable by the successful bidder as per prevailing government rules.
5. **Bid Security / Earnest Money** equal to the specified amount against each tender shall be:
  - o Uploaded electronically on EPADS v2.0, and
  - o Submitted in **original (Pay Order / Bank Draft)** in favor of *PESCO Sale Proceeds Account* in the office of Manager (Disposal) Room NO. 306, PESCO H/Q Peshawar before the closing date and time. Bids without valid bid security shall be rejected as **non-responsive**.
6. Detailed **bidding documents**, including terms & conditions, evaluation criteria, and disposal procedures, are available on **EPADS v2.0** for registered bidders.
7. **Manual / physical bids shall not be accepted**. All bids must be submitted electronically through EPADS within the stipulated date and time.
8. Bids shall be **opened electronically** on EPADS at the specified date and time in the presence of bidders/representatives who may choose to attend.
9. The **highest evaluated responsive bid** shall be accepted, subject to approval by the competent authority as per PPRA Rules.
10. PESCO reserves the right to **accept or reject any or all bids** at any time prior to acceptance, in accordance with **Rule 33 of PPRA Rules**, without assigning any reason.
11. In case of any grievance, bidders may approach the **Grievance Redressal Committee (GRC)** constituted under relevant provisions of PPRA, details of which are available on EPADS.

## PART-A: INSTRUCTIONS TO BIDDERS / PARTICIPANTS

<b>A. INSTRUCTIONS TO BIDDERS / PARTICIPANTS</b>	
<b>Scope of Bid</b>	Peshawar Electric Supply Company (PESCO) Ltd. wishes to receive E-Bids as per disposal notice and Bidding documents through E-PADS (version 2.0). Bidders can submit bids for one or more LOT. Successful bidder will be declared for each LOT separately as per his qualification and experience which will be determined on the basis of technical and financial evaluation.
<b>Language of Bid</b>	The E-Bid submitted by the Bidder through E-PADS (version 2.0), as well as all correspondence and documents relating to the bid exchanged by the Bidder and the PESCO, shall be in English (as the case may be).
<b>Amendment of Bidding Documents:</b>	At any time before the deadline for submission of E-Bid, PESCO, for any reason, either at its initiative or in response to a clarification requested by a prospective Bidder, amend the Bidding Documents. Such amendments shall take precedence over the existing document. The addendum will be binding on Bidders. It will be assumed that the amendments contained in such Addendum will have been taken into account by the Bidder in its bid.
<b>Access to Disposal Scrap</b>	The interested bidders are strongly encouraged to visit the stores during office timings to get first-hand information regarding the condition, make etc. of the items and their quantum before submitting the quotations. Interested Bidders Shall follow the PESCO's security protocols for visiting the stores.
<b>Condition and Specification</b>	All scrap material will be sold on "As is Where is basis".
<b>Location of Material</b>	As per stores mentioned in Tender Advertisement
<b>Qualification of the Bidder</b>	To qualify for the award of the Work Order, bidders must meet the mandatory evaluation criteria, as specified in the Bidding Document.
<b>Deadline for Submission of Bid</b>	As mentioned in Tender Advertisement.
<b>Late Bid</b>	Any Bid / Bid Security received after the prescribed deadline will not be considered.
<b>One Bid per Bidder</b>	Each Bidder shall submit only one Bid individually for one lot.
<b>Cost of Bidding</b>	The Bidder shall bear all costs associated with the preparation and submission of its bid, and the PESCO in no case be held responsible or liable for those costs.
<b>Method Of Bidding</b>	Single stage One Envelope Bidding procedure as per PPRA Rules.
<b>Bid Validity</b>	Validity of bid from the opening date shall be <b>120-Days</b> .
<b>Bid Security</b>	The amount of Fixed Bid Security mentioned against each LOT. ## Part C: General Conditions of Work Order / Release Order.

<b>General Conditions of Work Order</b>		
<b>1.</b>	<b>Applicable Law</b>	The Work Order shall be governed by the laws of the Islamic Republic of Pakistan.
<b>2.</b>	<b>Taxes, Duties and other applicable laws.</b>	The Work Order shall ensure compliance with local laws and applicable regulations. Any additional tax, levies, duties, or modification in the existing rates of tax and other applicable laws imposed during the pendency of this Work Order shall be paid by bidder.
<b>3.</b>	<b>Currency of Bid</b>	The Unit rate and the prices shall be quoted by Bidder entirely in Pak Rupees.
<b>4.</b>	<b>Effectiveness of Work Order</b>	This Work Order shall come into effect on the date of issuance of the Work Order.
<b>5.</b>	<b>Force Majeure</b>	<p><b><u>Definition</u></b> For this Work Order, “Force Majeure” means an unforeseeable event that is beyond the reasonable control of a Party, and which makes a Party’s performance of its obligations under the Work Order impossible as to be considered impossible under the circumstances. The Party affected by Force Majeure shall on the occurrence of such event leading to Force Majeure, immediately notify the other Party in writing and take all reasonable steps to overcome the Force Majeure.</p> <p><b><u>No Breach of Work Order</u></b> The failure of a Party to fulfill any of its obligations under the Work Order shall not be considered to be a breach of or default under this Work Order, insofar as such inability arises from an event of Force Majeure, provided that the party affected by such an event;</p> <ol style="list-style-type: none"> <li>a. has taken all reasonable precautions, due care and reasonable alternative measures to carry out the terms and conditions of this Work Order, and</li> <li>b. has informed the other Party as soon as possible about the occurrence of such an event.</li> </ol>
<b>6.</b>	<b>Confidentiality</b>	<p>Information relating to evaluation of bids and recommendations concerning to award of the Work Order shall not be disclosed by PESCO to the bidders or to any other person who is not officially concerned with the process, until the announcement of the result of evaluation.</p> <p>The Bidder shall not disclose or attempt to make public any information relating to the bidding documents, bidding process and award of the Work Order to any person or entity without the PESCO’s prior written consent.</p> <p>In case of any disclosure related to the bidding process and Work Orderual obligations at any stage by any bidder, PESCO may reject its bid / or terminate the Work Order.</p>
<b>7.</b>	<b>Disputes Resolution Procedure</b>	If any dispute arises between the parties (PESCO and the Successful Bidder), regarding the performance of the Work Order or anything contained in the Work Order, the matter shall be referred to the GRC Committee who will examine the matter in detail and give a decision.
<b>8.</b>	<b>Blacklisting</b>	Under PPRA-2004, PESCO can inter alia blacklist and debar bidders as PESCO Blacklisting / Debarment Policy available at PESCO Website.

4.	<b>Lifting Period of Scrap Material</b>	The contractor shall lift the allotted scarp material as per Work Order / Release Order within 21 working days from the date of issuance of Work Order / Release Order (duly confirmed) unless & otherwise extended by PESCO, under supervision of PESCO nominated committee.
5.	<b>Sub-Contracting</b>	Sub-contracting is NOT allowed under any circumstances.
6.	<b>Confidentiality</b>	The successful bidder while rendering the required services shall not release any information acquired from PESCO that is sensitive and should be kept strictly confidential irrespective of the fact it is specified or otherwise.
7.	<b>Penalty</b>	It would be binding for the contractor to lift the allotted quantity of scrap material within the specified time. Failure to do so shall result in a penalty of amount equal to 1% of the bid amount per day till such time the entire quantity is lifted, if the lifting is delayed.
8.	<b>Payment</b>	Contractor shall have to submit 100% payment (inclusive of all applicable taxes) within twenty-one (21) working days from issuance of LOA (Letter of Acceptance), upon the realization of payment in PESCO account Work Order shall be issued as per the quantities / weights allotted in the work order. The weights / counting shall be carried out in the presence of PESCO's Release Committee at spot before lifting the items. Further, the Contractor is solely responsible for payment of all applicable taxes/ levies etc. (if any) which will be adjusted from his offered rate, to respective authorities without any cost and consequences to be charged to the PESCO. In case of any change in rate of any tax by Government of Pakistan (GOP) after opening of tender (Bid), successful bidder shall pay the revised rate notified by the GOP.
09.	<b>Price Adjustment</b>	No Price Adjustment shall be made for any variation in the market prices, taxes / duties or change in wages or the Law.
10.	<b>Lifting Cost and Cost of Transportation</b>	The scrap material is to be lifted by the bidder at his own cost, transportation and labor, failing which a penalty of amount equal to 1% of the bid amount per day till such time the entire quantity is lifted, if the lifting is delayed, will be imposed. While Lifting of Material the Contractor shall comply with the Safety SOPs and provide necessary PPE to the labor involved in lifting the scrap material. Any mishap occurred to the personal shall be responsibility of the contractor.

11.	<b>Lifting of Scrap</b>	The Contractor would be responsible to arrange vehicle(s) and suitable number of workers for lifting of Scrap at his own cost. The Contractor will provide in advance the details of any vehicle(s) that is required to enter the premises of the PESCO Stores for lifting of Scrap material along with the details of the driver(s) of the vehicle and labor(s) involved in lifting of material. The Contractor shall be responsible for engaging adequate amount of manpower for providing quality services including their hygienic conditions / manners.
12.	<b>Time Schedule for Lifting</b>	The Contractor shall lift the scrap material during working hours on working days or on any other day and timing including gazette holidays (if required by the PESCO)
13.	<b>Requirement of SR and Gate Pass</b>	Scrap will be taken out from the PESCO's premises upon issuance of "Store Requisition and Gate Pass" by the PESCO authorities.
14.	<b>Use of PESCO's Property</b>	The Contractor shall not make any kind of excavation or construction including alteration or modification in the premises, including electrical appliances, sanitary fittings and other fitting / equipment, without the permission of PESCO in writing and further he shall have no right to use PESCO's property for his employee's personal purpose and residence.
15.	<b>Letter of Acceptance (LOA)</b>	The Letter of Acceptance (LOA) will be issued to bidder complied with evaluation criteria and quoted highest rates. The successful bidder is obliged to accept "letter of acceptance" (LOA) and deposit the remaining amount within twenty-one (21) Working Days of issuance of LOA, failing which, their bid security may be forfeited and the PESCO reserve the right to award the work to the 2 <sup>nd</sup> Highest Bidder.
16.	<b>Engagement in Other Business Activities</b>	The resource person will not be allowed to engage in any other business activity related to the PESCO. A strict punitive action will be taken against him if he ever found indulged in such acts and the decision of Chief Engineer (MM) PESCO, Peshawar will be final on this matter.
17.	<b>Failure to perform Work</b>	In case the successful bidder refuses to take up the work or fails to perform his obligations withing stipulated time of the Work Order, the bid Security / amount deposited to PESCO shall be forfeited and the Contractor shall be blacklisted / debarred for participation in future tenders of the PESCO as per PESCO Blacklisting / Debarment Policy.
18.	<b>Damage to PESCO's Property</b>	The PESCO reserves the right to recover any amount from the Contractor against any losses or damages incurred to the property, data, or employees of PESCO due to the negligence of Contractor or his workers.
19.	<b>Rejection of Proposal</b>	PESCO will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices like pooling, or giving bribery / prizes or any sum of money etc. to the persons responsible or engaged in disposal process or to other prospective bidders; or PESCO will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a Work Order within its jurisdiction if it at any time determines that the firm has engaged in corrupt or fraudulent practices during bidding process, or in executing a Work Order
