1. Who can participate?

Contractors registered with Pakistan Engineering Council (PEC) under relevant category with code of specialization as CE-10 (Registration / Renewal of Pakistan Engineering Counsel (PEC) for the Year 2025–2026).

2. From where tender Documents can be obtained?

E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) v2.0 at <https://vendors.epads.gov.pk/> for all the interested bidders registered on EPADS v2.0.

3. Earnest Money

- The Bid Security shall be submitted in the form of a Call Deposit Receipt (CDR) issued by any scheduled bank of Pakistan in favor of the Executive Engineer (Civil), Civil Works Division, GEPCO, Gujranwala. A scanned copy of the CDR must be uploaded along with the bid and original must be submitted to office of XEN (Civil), Civil Works Division GEPCO Gujranwala on or before submission time.
- The successful bidder will have to submit @ **10%** of the Contract Price as Performance Guarantee in the form of CDR at the time of signing of Contract Agreement as per bidding document.

4. Other Conditions

- Contractors must attach active registration certificates issued by the Punjab Revenue Authority (PRA) and the Federal Board of Revenue (FBR) with their bids.
- The bidder must have satisfactorily completed at least three (03) contracts of similar nature in Government, Semi-Government, or Autonomous Organizations during the last three (03) years. Relevant photocopies of work orders and completion certificates must be attached with the bid.
- Single-stage, single-envelope** procurement process will be adopted as per PPRA Rules.
- Bid validity period: **90-Days**.

- The GEPCO reserves the rights to accept or reject the tender as per PPRA Rules. (No conditional tender will be accepted).
