8. All details and documents as per Bidding Documents must be provided. Rebate offered must clearly be indicated in financial tender form in legible words.

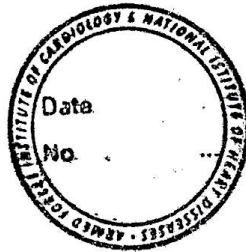
Bidding Documents can be obtained from Medical Stores during working hours on any working day on payment of Rs. 5000/- (rupees Five Thousand only) (non refundable).
