2. FESCO invites E-Bids from the Contractor registered with **Pakistan Engineering Council** with Category C-6 and above (C-6 to C-1) having specialization code EE-04 & EE-05 and renewed for the year **2025-26** alongwith valid registration active **PRA and FBR**, on **percentage basis (Above / below) on estimated amount / Tender Total Bid Amount (Unit Rate Based)** from eligible firms, Single Stage-One Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
3. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before **Tuesday, June 23, 2026 12:15 PM. E-bids will be opened on the same day at Tuesday, June 23, 2026 12:45 PM. Manual submission of Bids shall not be entertained.** Those vendors who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://vendors.epads.gov.pk/>. ELIGIBILITY

4. The Bidder meets the following requirements will be eligible for participation in the Bidding (**Through E-PADS V2.0**): -
 - a. Pakistan Engineering Council Certificate renewed for the **year 2025-26** with Category having Specialization Code as mentioned against above.
 - b. **The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last financial year.
 - c. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority (**PRA**).
 - d. Valid CNIC of Contractor / Managing Partner / Director of the firm.
 - e. The bidder having completed contract(s) of same nature along-with its completion successfully as main contractor within Ten years awarded by **WAPDA / NTDC / DISCOs** and consolidated value of these contract(s) **atleast equal to the estimated / B.O.Q (Cost) Amount / Tender amount**, will provide 5% performance security / guarantee otherwise 10% for new entrants contractor.
 - f. Bidder shall demonstrate **Cash or Cash Equivalents equal to 20% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last three months
 - g. Bids will be evaluated by the Evaluation Committee in accordance with the tender conditions in bidding documents & PPRA Rules.
 - h. All safety instructions narrated in NEPRA Safety Code must be adopted in true letter and spirit.
5. Eligible Bidders may obtain any information regarding Bidding from the Office of **Project Director (Construction) FESCO, Faisalabad on or before 18.06.2026.**
6. All bids must be accompanied by a Bid Security amounting to **2% on BOQ (Cost) amount / Tender Amount** each in favor of **Project Director Construction FESCO Faisalabad** issued from any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for 120 Days.
7. Tender rates and amounts should be filled in figures as well as in words. Tender documents should be signed as per general directions given in the **SBD**.
8. No rebate on tender rates will be acceptable.

9. All the procurement will be done according to PPRA Rules-2004 amendment up-to date.
10. Conditional Bid shall not be permitted and all the pages of tender will be marked as page No. and each page must be signed & stamped by the bidder.
11. The bids covering partial and incomplete work shall be rejected.

Note: -

- i) **The bid validity must be as specified in the tender documents.**
- ii) **Tenders will be opened on PPRA EPADS V2.0 on the date and time mentioned above.**
- iii) **A Bid Security/Guarantee as indicated E-bidding documents must accompany the bid; otherwise, the bid will be rejected.**
- iv) **Original Bid Security/Guarantee must be submitted in the office of the undersigned before the closing time for receiving tenders.**

- vii) **Conditional tenders will not be accepted.**
