The bidder shall submit sealed Bid security/Guarantee in original mentioned against each tender valid for 90 (ninety) days in the form of Bank Guarantee/CDR issued by any scheduled Bank of Pakistan (having rating A+ or above) in favour of Chief Executive Officer IESCO Islamabad, before the bid closing time, failing which the bid(s) shall be considered non-responsive.
6. The bid should be for full quantity of tender and bid for less quantity of tender will not be accepted.
