From Office Cantonment Board Peshawar Auction
Auction Notice Regarding Parking Stands Cantonment Board Peshawar

General public and all business persons, especially parking stand contractors, are hereby informed that Cantonment Board Peshawar will hold an auction for the rights to collect parking fees from the following parking stands for a period of three (03) years, from 15th August 2026 to 14th August 2029. The auction will be held on Thursday, 06th July 2026, at 11:00 AM at the office of Cantonment Board Peshawar. Details are as follows:

1. The contract period will be 03 years (15-08-2026 to 14-08-2029).
2. Every bidder must submit the above-mentioned Call Deposit from any bank in favor of the Cantonment Executive Officer Peshawar, along with a copy of CNIC / Registration / NTN, before submitting a bid. Except for the 1st Highest Bidder and 2nd Highest Bidder, the Call Deposits of all other bidders will be returned.
3. Persons wishing to participate in the bid must submit their Call Deposit 2 days before the auction date so that the Cantonment Board Peshawar office can verify the submitted Call Deposit from the relevant bank. No Call Deposit will be accepted on the auction date.
4. The successful bidder shall be bound to deposit $\frac{1}{4}$ of the bid amount on the spot. The said amount will be adjusted in the last installment of the contract.
5. If the successful bidder fails to deposit $\frac{1}{4}$ of the bid amount as per auction conditions, his Call Deposit in favor of Cantonment Board Peshawar will be forfeited and no excuse will be accepted. If Cantonment Board Peshawar considers the offer of the 2nd Highest Bidder to be appropriate as per market value, the 2nd Highest Bidder shall be bound to deposit $\frac{1}{4}$ of his offer. Otherwise, the Call Deposit of the 2nd Highest Bidder will also be forfeited in favor of Cantonment Board Peshawar and no excuse will be accepted.
6. The bid will be for one year, with a 10% increase for each subsequent year.
7. The successful bidder shall be bound to deposit the bid amount in advance installments by the 5th of each month.
8. The successful bidder shall be bound to submit a cheque for the complete contract amount for parking fees for the 03-year period along with stamp paper in favor of the Cantonment Executive Officer Peshawar. If the successful bidder happily completes his contract period/contract as per the auction conditions, the said cheque and stamp paper will be returned to him at the end of the contract period.

9. After final approval from the Executive Officer, the successful bidder shall be bound to complete the contract for parking fee collection at his own expense within 7 days.
10. The successful bidder shall be bound to deposit income tax on the bid amount as per the government schedule within 07 days after final approval of the bid by the Executive Officer.
11. If the successful bidder fails to deposit his dues installment by the 05th of each month, he shall be bound to pay a fine of Rs. 5,000/- per month. In case of continuous delay of more than 10 days, the contract will be suspended. The staff of Cantonment Board Peshawar shall be authorized to take possession of the said parking stand, and the entire responsibility will lie with the contractor. No excuse from the bidder/contractor will be accepted.
12. The contractor shall be authorized to collect parking fees at the following rates:

1	100 Rupees - Car
2	50 Rupees - Motorcycle

13. The successful contractor shall be bound to clearly write the rate on the token/ticket as per the rate approved by the Cantonment Board. Further, the contractor shall submit a sample of the receipt within 07 days of contract approval to the Cantonment Board for approval, which will bear the clear stamp of the Cantonment Board. The successful bidder shall display a board showing the parking rate outside the parking stand. In case of overcharging, a fine of Rs. 10,000 will be collected for each instance of overcharging, and in case of 5 continuous instances of overcharging, the contract shall be suspended.
14. In case of any emergency or unexpected situation in the country, if a written order is issued by the Government of Pakistan or Cantonment Board Peshawar, if the parking stand is ordered to be closed, the contractor/successful bidder shall be bound to comply with these orders. In such closure, for the fixed days, the authority for concession/exemption regarding the amount shall rest with Cantonment Board Peshawar. The contractor shall be bound to accept whatever decision Cantonment Board Peshawar takes in this regard.
15. The successful bidder shall be required to obtain any type of NOC from the concerned departments at his own expense. The entire responsibility shall lie with the concerned contractor and the Cantonment Board shall not be considered responsible in any way in this regard.
16. The Cantonment Board shall not be responsible for any loss due to security conditions.
17. Defaulter of Cantonment Board or State of Pakistan, any provincial or federal institution, shall be not be authorized to participate in the bid.
18. The successful bidder shall not be authorized to sublet/transfer the contract without the approval of Cantonment Board Peshawar.
19. The successful bidder shall not be authorized to employ any non-local / non-registered / Afghan national labor or employee.
20. The undersigned shall have the authority to approve or reject the contract without assigning any reason (Reference PPRA Rule 33(1) 2004).
21. In case of any dispute between the successful bidder and Cantonment Board Peshawar, both parties shall approach DML&C Peshawar for arbitration. The decision of DML&C Peshawar shall be considered final and both parties shall be bound to accept the said decision.
22. The undersigned authorized to except or reject any counter bid before the approval of the contract if any firm / contract offer a counter bid.
23. If a minimum of 03 firms/persons bid for the contract of all 11 mentioned parking stands, preference will be given to them, provided that the firm or person submits a Call Deposit of 73 lakh rupees in favor of the Cantonment Executive Officer Peshawar. Otherwise, the auction of each parking stand will be held separately, turn by turn, according to serial number.

24. Cantonment Board Peshawar is conducting the auction of the mentioned parking stands according to the law, but the bidder himself shall handle/manage the matters of Law and Order.
25. In case any parking stand/side is affected by any Cantt Board project, the contractor shall have to vacate the concerned parking stand immediately. After that, for the remaining period, the said contract will be suspended after calculation between both parties according to the existing rules.
26. In case of violation of any one of the mentioned conditions, the contract will be cancelled.
27. If for any reason the bid/auction is not held on the fixed date, then the bid/auction will be held again on 07th July, 2026 at 11:00 AM and the third time bid/auction will be held on 08th July, 2026 at 11:00 AM.
28. No new advertisement will be issued for the dates of the second auction or third auction.
